BIDDING FOR THE PROCUREMENT OF BCDA IT EQUIPMENT AND SOFTWARE 2018

RESOLUTION OF AWARD (RESO NO. BG2018-025)

WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA) has put on bid the Procurement of BCDA IT Equipment and Software 2018 with an Approved Budget for the Contract (ABC) of Eight Million Six Hundred Eighty-One Thousand Pesos & 00/100 (PhP8,681,000.00), inclusive of all applicable taxes and fees.

WHEREAS, the BAC for Goods, through its Secretariat, advertised the Invitation to Bid on 12 September 2018 in the following:

- DBM Philippine Government Electronic Procurement System (PhilGEPS); a)
- b) BCDA Website; and,
- In a conspicuous place reserved for the purpose in the premises of BCDA c)

WHEREAS, in response to said advertisements, five (5) prospective bidders bought the bid documents, namely:

- Quartz Business Products Corp.; a)
- b) Advance Solutions Inc.;
- Columbia Technologies Inc.; c)
- d) Geodata System Technologies; and,
- Phil-Data Business Systems, Inc. e)

WHEREAS, on 04 October 2018, on the scheduled Opening of Bids, the BAC for Goods received proposals from above-mentioned bidders for the following respective lots:

- Quartz Business Products Corp submitted proposals for Lots A, B, & D;
- Advance Solutions Inc. submitted proposals for Lots B, C, & D; b)
- Columbia Technologies Inc. submitted proposals for Lots A, B, C, D, & G; c)
- d) Geodata System Technologies, Inc. submitted proposals for Lot F; and,
- Phil-Data Business Systems, Inc. submitted proposals for Lot A.

WHEREAS, during this event, all bidders having submitted the required eligibility documents were found eligible, thus, their financial proposals were opened.

WHEREAS, after preliminary evaluation of the submitted bids by the BAC for Goods, Columbia Technologies Inc. passed and was declared as the Lowest Calculated Bid for Lots A & B and was declared as the Single Calculated Bid for Lot G; Advance Solutions Inc. passed and was declared as the Lowest Calculated Bid for Lots C and D; and, Geodata Systems Technologies, Inc. passed and was declared as the Single Calculated Bid for Lot F. The Abstract of Bids is hereby attached as "Annex "A".



WHEREAS, in view of the foregoing and consistent with Section 34 of Rule X – Post-Qualification of the Revised Implementing Rules and Regulations of Republic Act No. 9184, the Technical Working Group (TWG) of the BAC for Goods conducted Post-Qualification on two separate dates, 11 & 12 October 2018 to determine whether the bidders: Columbia Technologies Inc., Advance Solutions Inc., and Geodata Systems Technologies, Inc. are compliant with, and are responsive to the requirements and conditions specified in the Bidding Documents.

WHEREAS, upon post-qualification conducted by the TWG and after careful examination, validation and verification of all the eligibility, technical and financial documents submitted by Columbia Technologies Inc., Advance Solutions Inc., and Geodata Systems Technologies, Inc., their respective bids have been found Complying and Responsive. *The Post-Qualification Report is hereby attached as Annex "B"*.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee for Goods, hereby **RESOLVE** as it is hereby **RESOLVED** to recommend the following:

1. To declare **COLUMBIA TECHNOLOGIES INC.** as the bidder with the Lowest Calculated and Responsive Bids for **Lots A & B** and Single Calculated and Responsive Bid for **Lot G** in the Bidding for the Procurement of BCDA IT Equipment and Software 2018;

To declare **ADVANCE SOLUTIONS**, **INC.** as the bidder with the Lowest Calculated and Responsive Bids for **Lots** C & D in the above-stated Bidding; and,

To declare **GEODATA SYSTEMS TECHNOLOGIES**, **INC.** as the bidder with Single Calculated and Responsive Bid **for Lot F** in the above-stated Bidding;

- 2. To award the Contracts to **COLUMBIA TECHNOLOGIES INC.** in the following Lots with respective amounts, inclusive of all applicable taxes and fees:
 - a. For Lot A: Four Million Four Hundred Sixty-One Thousand One Hundred Forty-Two (PhP4,461,142.00);
 - b. For Lot B: Four Hundred Eight-Two Thousand Eight Hundred Fifty-Four Pesos (PhP482,854.00); and,
 - c. For Lot G: Two Hundred Eighty-Three Thousand One Hundred Eighty-Five Pesos (PhP283,185.00);
- 3. To award the Contracts to **ADVANCE SOLUTIONS**, **INC.** in the following Lots with respective amounts, inclusive of all applicable taxes and fees:
 - a. For Lot C: Forty-Four Thousand Two Hundred Eighty-Eight Pesos (PhP44,288.00); and
 - b. For Lot D: Two Hundred Fifteen Thousand Three Hundred Thirty-One Pesos (PhP215,331.00);
- 4. To award the Contract to **GEODATA SYSTEMS TECHNOLOGIES, INC.** in the amount of One Million One Hundred Twenty-Seven Thousand Two Hundred Pesos (PhP1,127,200.00) for Lot F, inclusive of all applicable taxes and fees;

- 5. To issue the Notices of Award to COLUMBIA TECHNOLOGIES INC., ADVANCE SOLUTIONS, INC., and, GEODATA SYSTEMS TECHNOLOGIES, INC. (copy attached);
- 6. To declare failure of bidding for Lots E & H;
- 7. To direct the Information and Communications Technology Department, being the end-user, to furnish the BAC for Goods of copies of the duly conformed to Notice of Award, Notices to Proceed and the duly executed contract agreements.
