**RESOLUTION OF AWARD
(RESO NO. BG 2020-013)**

WHEREAS, the **BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA)** has bid out the **Procurement of BCDA IT Equipment and Software 2020** with the following **Approved Budgets for the Contracts (ABC)**, inclusive of all applicable taxes and fees:

WHEREAS, the BAC for Goods, through its Secretariat, advertised the Invitation to Bid on 18 September 2020 in the following:

1. DBM Philippine Government Electronic Procurement System (PhilGEPS);
2. BCDA Website; and
3. Conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, in response to said advertisements, the following four (4) companies submitted their bids for the following specific lot/s:

WHEREAS, there were no bids received for **Lot A**.

WHEREAS, during the Opening of Bids on 09 October 2020, the BAC for Goods received and opened proposals from the above-mentioned bidders. During this activity, the eligibility documents submitted by the bidders have initially passed eligibility requirements for **Lot B, Lot C, Lot E and Lot F** of the **BCDA IT Equipment and Software 2020**, except for **Lot D**. All bidders, except the bidder for **Lot D**, were found eligible, thus, their financial proposals were opened.

WHEREAS, after the preliminary evaluation of the submitted bids, the BAC for Goods had the following observation:

1. **CIM Technologies, Inc.** passed the eligibility requirements and technical proposal, and submitted a financial proposal of **Php701,200.00**, inclusive of all applicable taxes and fees for **Lot B**, which is below the ABC. **CIM Technologies, Inc.** was declared the Single Calculated Bid for **Lot B**.

2. **Pronet Systems Integrated Network Solution, Inc.** passed the eligibility requirements and technical proposal, and submitted a financial proposal of **Php3,312,773.00**, inclusive of all applicable taxes and fees for **Lot C**, which is below the ABC. **Pronet Systems Integrated Network Solution, Inc.** was declared the Single Calculated Bid for **Lot C**.

Further, **Pronet Systems Integrated Network Solution, Inc.** submitted a bid proposal for **Lot D**. However, it did not pass the eligibility requirements and technical proposal. Therefore, it was declared ineligible for the post-qualification, per Section 35.1 (b) of the RIRR of RA 9184.

3. **American Technologies, Inc.** passed the eligibility requirements and technical proposal, and submitted a financial proposal of **Php 221,312.00**, inclusive of all applicable taxes and fees for **Lot E**, which is below the ABC. **American Technologies, Inc.** was declared the Single Calculated Bid for **Lot E**.
4. **EGM Global System Technologies, Inc. Joint Venture with Power Craft Solutions and Data Infrastructure, Inc.** passed the eligibility requirements and technical proposal, and submitted a financial proposal of **Php7,328,669.00**, inclusive of all applicable taxes and fees for **Lot F**, which is below the ABC. **EGM Global System Technologies, Inc. Joint Venture with Power Craft Solutions and Data Infrastructure, Inc.** was declared the Single Calculated Bid for **Lot F**.

The Abstract of Bids is hereby attached as "Annex "A".

WHEREAS, in view of the foregoing and consistent with Section 34 of Rule X – Post-Qualification of the Revised Implementing Rules and Regulations of Republic Act No. 9184, the BAC-G Technical Working Group (TWG) conducted Post-Qualification on 21-26 October 2020 to determine if these companies: 1) **CIM Technologies, Inc.**; 2) **Pronet Systems Integrated Network Solution, Inc.**; 3) **American Technologies, Inc.**; and 4) **EGM Global System Technologies, Inc. Joint Venture with Power Craft Solutions and Data Infrastructure, Inc.**, are compliant with, and are responsive to the requirements and conditions specified in the Bidding Documents.

WHEREAS, upon post-qualification conducted by the BAC-G TWG and after careful examination, validation, and verification of all the eligibility, technical and financial documents submitted by **CIM Technologies, Inc.**; **Pronet Systems Integrated Network Solution, Inc.**; **American Technologies, Inc.**; and **EGM Global System Technologies, Inc. Joint Venture with Power Craft Solutions and Data Infrastructure, Inc.**, their respective bids have been found Complying and Responsive. *The Post-Qualification Report is hereby attached as Annex "B".*

NOW, THEREFORE, We, the Members of the Bids and Awards Committee for Goods, hereby **RESOLVE** as it is hereby **RESOLVED** to recommend the following:

1. To declare **CIM Technologies, Inc.** as the Single Calculated and Responsive Bidder for the Procurement of **Lot B** of the **BCDA IT Equipment and Software 2020** and to

award the contract to **CIM Technologies, Inc.** in the amount of **Seven Hundred One Thousand Two Hundred Pesos and 00/100 (Php701,200.00)**, inclusive of all applicable taxes and fees;

2. To declare **Pronet Systems Integrated Network Solution, Inc.** as the Single Calculated and Responsive Bidder for the Procurement of **Lot C** of the **BCDA IT Equipment and Software 2020** and to award the contract to **Pronet Systems Integrated Network Solution, Inc.** in the amount of **Three Million Three Hundred Twelve Thousand Seven Hundred Seventy Three Pesos and 00/100 (Php3,312,773.00)**, inclusive of all applicable taxes and fees;
3. To declare **American Technologies, Inc.** as the bidder with the Single Calculated and Responsive Bid for the Procurement of **Lot E** of the **BCDA IT Equipment and Software 2020** and to award the contract to **American Technologies, Inc.** in the amount of **Two Hundred Twenty One Thousand Three Hundred Twelve Pesos and 00/100 (Php 221,312.00)**, inclusive of all applicable taxes and fees;
4. To declare the **EGM Global System Technologies, Inc. Joint Venture with Power Craft Solutions and Data Infrastructure, Inc.** as the Single Calculated and Responsive Bidder for the Procurement of **Lot F** of the **BCDA IT Equipment and Software 2020** and to award the contract to the **EGM Global System Technologies, Inc. Joint Venture with Power Craft Solutions and Data Infrastructure, Inc.** in the amount of **Seven Million Three Hundred Twenty Eight Thousand Six Hundred Sixty Nine Pesos and 00/100 (Php7,328,669.00)**, inclusive of all applicable taxes and fees;
5. To issue the Notices of Award to 1) **CIM Technologies, Inc;** 2) **Pronet Systems Integrated Network Solution, Inc.;** 3) **American Technologies, Inc.;** and the 4) **EGM Global System Technologies, Inc. Joint Venture with Power Craft Solutions and Data Infrastructure, Inc.;** (*copy attached*);
6. To direct the End-user unit to furnish the BAC-G copies of the duly conformed **Notices of Award, Notices to Proceed** and the **duly executed agreements/contracts;**
7. To recommend to the End-User to conduct a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, including its cost estimates and delivery schedule of **Lot A** and **Lot D** of the **BCDA IT Equipment and Software 2020**, pursuant to Section 35.2 of the Revised IRR of RA 9184; and
8. To proceed with the re-bidding of the Procurement of **Lot A** and **Lot D** of the **BCDA IT Equipment and Software 2020**, pursuant to Section 35.3 of the Revised IRR of RA 9184.
