## **DECLARATION OF ELIGIBLE AND SHORTLISTED BIDDERS**

## Procurement of the Construction Management and Supervision for the New Clark City Connecting Road Package 1

WHEREAS, The BCDA President and CEO approved the procurement of the above consulting service with an Approved Budget for the Contract (ABC) in the amount of THIRTY-NINE MILLION NINE HUNDRED NINETY-FIVE THOUSAND TWO HUNDRED PESOS and 00/100 (Php39,995,200.00), inclusive of all applicable taxes and fees, to commence upon receipt of the Notice to Proceed (NTP).

WHEREAS, On 29 September 2020, the Bids and Awards Committee for Consulting Services (BAC-C) advertised the Request for Expression of Interest for the CONSULTING SERVICES FOR THE CONSTRUCTION MANAGEMENT AND SUPERVISION OF NEW CLARK CITY CONNECTING ROAD PACKAGE 1 in the BCDA Website, PhilGEPS website and in a conspicuous place in the premises of BCDA continuously for seven (7) days;

**WHEREAS,** The procurement of the said services shall be undertaken through competitive bidding using Quality Cost-Based Evaluation (QCBE) procedure with 70% minimum score to be shortlisted.

**WHEREAS,** In response to the said advertisement, the following firms responded and secured the Eligibility Documents:

- a. KE Asia, Inc.;
- b. Urban Integrated Consultants, Inc. (UICI); and
- c. TCGI Engineers (TCGI).

**WHEREAS,** The above proponents submitted their accomplished eligibility documents before the deadline of submission on 14 October 2020, 12:00NN.

**WHEREAS,** On the same day, at 1:00 PM, the accomplished eligibility documents of the three (3) proponents were opened and checked based on the non-discretionary "pass/fail" criterion. The three (3) proponents passed the Eligibility Check and were evaluated for shortlisting;

WHEREAS, the results of evaluation based on the submitted Eligibility Proposals are as follows:

**WHEREAS**, based on the approved detailed evaluation criteria, UICI and TCGI each garnered a total score above the required minimum score of 70%;

WHEREAS, KE Asia Inc. garnered a total score of 56.62%, below the required minimum score of 70%;

**NOW, THEREFORE,** we, the members of the Bids and Awards Committee for Consulting Services, hereby RESOLVE, as it is hereby RESOLVED to:

- 1. DECLARE AS SHORTLISTED and ELIGIBLE to proceed to the next stage of bidding activities the following proponents:
  - a. Urban Integrated Consultants, Inc..; and
  - b. TCGI Engineers.
- 2. ISSUE Notice of Eligibility to the said proponents inviting them to bid for the Procurement of the Construction Management and Supervision for the New Clark City Connecting Road Package 1; and
- 3. RECOMMEND to the Head of Procuring Entity (HoPE) the approval of the foregoing findings.
