## **DECLARATION OF HIGHEST RATED BID (HRB)**

## CONSULTING SERVICES FOR THE CONSTRUCTION MANAGEMENT AND SUPERVISION (CMS) FOR THE NEW CLARK CITY (NCC) CONNECTING ROAD PACKAGE 1

WHEREAS, The BCDA President and CEO approved the procurement of the above consulting services with an Approved Budget for the Contract (ABC) in the amount of Pesos: Thirty Nine Million Nine Hundred Ninety Five Thousand Two Hundred Pesos and 00/100 (PhP39,995,200.00), inclusive of all applicable taxes and fees, to commence upon receipt of the Notice to Proceed (NTP).

WHEREAS, On 29 September 2020, the Bids and Awards Committee for Consulting Services (BAC-C) advertised the Request for Expression of Interest (REI) for the said consulting services in the BCDA Website, PhilGEPS Website and in a conspicuous place in the premises of BCDA;

WHEREAS, On 21 October 2020, the Bids and Awards Committee for Consulting Services (BAC-C) issued BAC-C RESOLUTION NO. BC2020-021, declaring the following bidders as SHORTLISTED and ELIGIBLE to proceed to the next stage of the bidding process:

- a. Urban Integrated Consultants, Inc.; and
- b. TCGI Engineers.

WHEREAS, Urban Integrated Consultants, Inc. and TCGI Engineers purchased bid documents and submitted their Technical and Financial Proposal before the deadline on 19 November 2020 at 9:00 AM.

WHEREAS, the evaluation procedure adopted to be declared as the bidder with Highest Rated Bid (HRB) was the Quality-Cost Based Evaluation (QCBE) procedure. The consultant must pass the required 70% minimum technical score;

**WHEREAS,** On 19 November 2020, the above-mentioned bidders submitted their Technical and Financial Proposals before the deadline at 9:00AM.

**WHEREAS,** On the same day, at 10:00AM, the Technical Proposal of each bidder was opened and the BAC conducted preliminary technical evaluation.

**WHEREAS,** The TWG conducted the evaluation of technical proposals based on the approved detailed evaluation criteria. The consolidated results of the technical evaluation are as follows:
