**Procurement of the Annual License Subscription of Integrated Security Suite–
Endpoint Security and Data Center Security**

RESOLUTION NO. BG 2020- 014

WHEREAS, the **BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA)** has put on bid the **Procurement of the Annual License Subscription of Integrated Security Suite–Endpoint Security and Data Center Security** with an Approved Budget for the Contract (ABC) in the amount of **One Million Five Hundred Thousand Pesos (Php1,500,000.00)**, inclusive of all applicable government taxes and fees;

WHEREAS, the **BAC-G**, through its Secretariat, advertised the **Invitation to Bid** on 21 September 2020 in the following:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, in response to the said advertisements, **CT Link Systems, Inc.** bought the bid documents;

WHEREAS, on the scheduled Opening of Bids on 13 October 2020, only **CT Link Systems, Inc.** submitted a bid proposal for the **Procurement of the Annual License Subscription of Integrated Security Suite–Endpoint Security and Data Center Security**;

WHEREAS, **CT Link Systems, Inc.**, having submitted the required eligibility documents was declared “eligible”, thus, its financial proposal was opened;

WHEREAS, **CT Link Systems, Inc.**, the lone “eligible” bidder submitted the bid for the **Procurement of the Annual License Subscription of Integrated Security Suite–Endpoint Security and Data Center Security** in the amount of **One Million Four Hundred Ninety Thousand Pesos (Php1,490,000.00)**, inclusive of all applicable taxes and fees. *The Abstract of Bids is hereby attached as Annex “A”*;

WHEREAS, on 26-27 October 2020, the **Technical Working Group (TWG)** conducted post qualification of **CT Link Systems, Inc.**, to determine whether it complies with, and is responsive to the requirements and conditions specified in the Bidding Documents;

WHEREAS, after the conduct of post-qualification by the **TWG** and careful examination, validation and verification of all the eligibility, technical and financial documents submitted to the **BAC-G** by **CT Link Systems, Inc.**, its bid is declared Complying and Responsive. *The Copy of Post Qualification Report is hereto attached as Annex “B”*;


NOW, THEREFORE, foregoing premises considered, we, the members of the **BAC-G**, hereby **RESOLVE**, as it is hereby resolved, to recommend the following:


1. To declare **CT Link Systems, Inc.** as the bidder with the Single Calculated and Responsive Bid for the **Procurement of the Annual License Subscription of Integrated Security Suite–Endpoint Security and Data Center Security**;


2. To award the Contract to **CT Link Systems, Inc.** in the amount of **One Million Four Hundred Ninety Thousand Pesos (Php1,490,000.00)**, inclusive of all applicable taxes and fees;
3. To issue the corresponding **Notice of Award** to **CT Link Systems, Inc.** (Copy Attached); and
4. To direct the **Information and Communications Technology Department (ICTD)**, being the end-user unit, to furnish the **BAC-G** copies of the duly conformed **Notice of Award**, **Notice to Proceed** and the **duly executed agreement/contract**.
