**PROCUREMENT OF MANPOWER SERVICES FOR
GENERAL SUPPORT AND JANITORIAL SERVICES FOR BCDA (LOT 1)**

**RESOLUTION DECLARING A FAILURE OF BIDDING FOR LOT 1
(RESO NO. BG MS 2020-0021)**

WHEREAS, the **Bases Conversion and Development Authority (BCDA)**, through its 2020 Corporate Operating Budget has bid out the **Procurement of Manpower Services for General Support and Janitorial Services for BCDA (LOT 1) under Two-Year Contract** with the budget amounting to **Php 27,490,652.04**, inclusive of all applicable taxes, charges, duties and fees, being the Approved Budget for the Contract (ABC) for the first year only;

WHEREAS, the BAC for Goods (BAC-G), through its Secretariat, advertised the Invitation to Bid on 24 November 2020 in the following:

1. DBM Philippine Government Electronic Procurement System (PhilGEPS);
2. BCDA Website; and
3. Conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, in response to said advertisements, the following three (3) companies submitted their bids:

1. DBP Service Corporation;
2. Wizard Manpower and Allied Services, Inc.; and
3. Front Runners Property Maintenance and Gen. Services.

WHEREAS, during the Opening of Bids on 16 December 2020, **DBP Services Corporation** and **Front Runners Property Maintenance and Gen. Services** were declared **eligible** while **Wizard Manpower and Allied Services, Inc.** was declared **ineligible** for failure to submit a valid and subsisting PhilGEP's Platinum Membership Certificate and Business Permit;

WHEREAS, after the opening of the financial bid proposals, **Front Runners Property Maintenance and Gen. Services** offered the financial bid amounting to **Php26,691,978.00** while **DBP Service Corporation** offered **Php27,473,942.88**. *The Abstract of Bids is hereby attached as "Annex "A".*

WHEREAS, in accordance with Section 32 of the Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA) No. 9184, the BAC-TWG conducted detailed evaluation of the financial bids and both were declared to be non-responsive bids due to the following:

1. **Front Runners Property Maintenance and Gen. Services** failed in its financial bid when it submitted its financial proposal with several errors. to wit:
 - a. The Bidder inadvertently exchanged the required number of employees between the positions with Gross Monthly Rates of P14,630.00 and P13,904.00 for 10 and 37 number of employees, respectively, instead of 5 and 42 number of employees, thus, going above the approved rate for the employees with the Gross Monthly Rate of P14,630.00 by P88,078.50; and
 - b. The Bidder's computation of the VAT is only computed against the labor cost of the manpower services, instead of the labor cost plus the profit margin.
2. The **DBP Service Corporation** used a lower rate for the mandatory Philhealth contribution of 2.75% instead of 3.5%, thus after recomputing, the correct financial proposal of the said bidder should be **Php27,544,531.68**, which is Php53,879.64 higher than the ABC.

WHEREAS, based on the aforementioned findings, the BAC-G declared a failure of bidding pursuant to Section 35.1 of the RIRR of RA 9184, to wit:

"35.1. The BAC shall declare the bidding a failure when:

- a) xxx
- b) *All prospective bidders are declared ineligible;*
- c) **All bids fail to comply with all the bid requirements or fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation; or**
- d) xxx

NOW, THEREFORE, We, the Members of the Bids and Awards Committee for Goods, hereby **RESOLVE** as it is hereby **RESOLVED** to recommend the following:

1. To declare a Failure of Bidding for the **Procurement of Manpower Services for General Support and Janitorial Services for BCDA (Lot 1)**;
2. To recommend to the end-user, Organizational Development and Management Department (ODMD) to conduct a mandatory review and evaluation of the terms, conditions, and specifications of the Bidding Documents, including its cost estimates, and other requirements for the Procurement of **Manpower Services for General Support and Janitorial Services for BCDA (Lot 1)**, pursuant to Section 35.2 of the RIRR of RA 9184; and

3. To proceed with the Rebidding of **Procurement of Manpower Services for General Support and Janitorial Services for BCDA (Lot 1)**, with an approved budget, pursuant to Section 35.3 of the RIRR of RA 9184.


