# PROCUREMENT OF MANPOWER SERVICES FOR TECHNICAL AND ADMINISTRATIVE SUPPORT SERVICES FOR BCDA (LOT 2)

# RESOLUTION OF AWARD (RESO NO. BG MS 2020-0022)

WHEREAS, the Bases Conversion and Development Authority (BCDA), through its 2020 Corporate Operating Budget has bid out the Procurement of Manpower Services for Technical and Administrative Support Services for BCDA (Lot 2) with the budget amounting to Php78,448,712.28, inclusive of all applicable taxes, charges, duties and fees, being the Approved Budget for the Contract (ABC) (for the first year only);

**WHEREAS**, the BAC for Goods (BAC-G), through its Secretariat, advertised the Invitation to Bid on 24 November 2020 in the following:

- 1. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- 2. BCDA Website; and
- 3. Conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, on 09 December 2020, BAC-G clarified through a Bid Bulletin No. BAC-G MS-2020-001 that the Procurement of Manpower Services for Technical and Administrative Support Services for BCDA (Lot 2) is under a One (1) year Contract only, extendable for another year;

**WHEREAS**, in response to said advertisements, the following three (3) companies/bidders submitted their bids:

- 1. DBP Service Corporation;
- 2. Wizard Manpower and Allied Services, Inc.; and
- 3. ITren Ventures, Inc.

**WHEREAS**, during the Opening of Bids on 16 December 2020, the BAC-G received and opened the eligibility documents from the above-mentioned bidders. Of the three (3), only **DBP Service Corporation** passed the preliminary evaluation and was declared Eligible.

**WHEREAS**, the following bidders were disqualified and were declared Ineligible for the following reasons:

- 1. Wizard Manpower and Allied Services failed to comply with the submission of a valid Philgeps' Platinum Membership and Mayor's Permit, which were both expired;
- 2. ITren Ventures Inc. failed to submit a single largest completed contract (SLCC) that is similar to the requirements of the Project being bid. Itren submitted a contract for







the Facilities Maintenance Services for Adamson University, which category is similar to that of Lot 1;

**WHEREAS,** after the opening of the financial bid proposal and conduct of bid evaluation of the submitted bids of **DBP Service Corporation**, the BAC-G found the bid of **DBP Service Corporation** as the Single Calculated Bid. *The Detailed Evaluation of Bid is hereby attached as "Annex "B"* 

**WHEREAS,** consistent with Section 34 of Rule X "Post-Qualification" of the Revised Implementing Rules and Regulations of Republic Act No. 9184, the BAC-G Technical Working Group (TWG) conducted a Post-Qualification on 22 December 2020 of **DBP Service Corporation** and after careful examination, validation, and verification of all the eligibility, technical, and financial documents submitted, found its documents to be in order. In view of the foregoing, the BAC-G declared **DBP Service Corporation** as the single calculated and responsive bid. *The Post-Qualification Report is hereby attached as Annex "C*".

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee for Goods, hereby **RESOLVE** as it is hereby **RESOLVED** to recommend the following:

- To declare DBP Service Corporation as the Single Calculated and Responsive Bid for the Procurement of Manpower Services for Technical and Administrative Support Services for BCDA (Lot 2) and to award the contract to DBP Services Corporation in the amount of Seventy-Eight Million Four Hundred Forty-Eight Thousand Four Hundred One and 84/100 Pesos (Php 78,448,401.84), inclusive of all applicable taxes and fees;
- To issue the Notice of Award to DBP Service Corporation for the Procurement of Manpower Services for Technical and Administrative Support Services for BCDA (Lot 2) under a One (1) year Contract, extendable for another year, pursuant to Bid Bulletin No. BACG MS-2020-001;
- 3. To direct the end-user, Organizational Development and Management Department (ODMD), to furnish the BAC-G copies of the Notice of Award and Notice to Proceed duly-conformed by **DBP Service Corporation** and the duly-executed agreements/contracts with **DBP Service Corporation**;
