**DECLARATION OF SHORTLISTED ELIGIBLE BIDDER**

**Consulting Services for the Enhancement and Implementation of the Build Build Build Portal**

**WHEREAS**, a Memorandum of Agreement (MOA) was executed among the Department of Finance (DOF), Department of Public Works and Highways (DPWH), Department of Transportation (DOTr), Department of Budget and Management (DBM), National Economic and Development Authority (NEDA), and Bases Conversion and Development Authority (BCDA) for the creation of the inter-agency Build Build Build Core Committee (BBB-CC);

**WHEREAS**, Section VI of the MOA provides that, DOTr, DPWH and BCDA shall share equally in all the costs and expenses connected with the promotional activities or events and communication plans organized by the parties through their joint efforts, including expenses related to the Build Build Build (BBB) Portal;

**WHEREAS**, the same Section provides that, BCDA may advance the costs or expenses related to the BBB program for 2017 and 2018, subject to reimbursement by the DOTr and DPWH;

**WHEREAS**, Section IV E of the MOA provides that, "BCDA, with authority from all the parties, shall be responsible for the procurement of the consulting services for the development, maintenance, administration and management of the BBB Portal;"

**WHEREAS**, BCDA, pursuant to the authority granted in the MOA, is undergoing the procurement of the Consulting Services for the Enhancement and Implementation of the Build Build Build (BBB) Portal;

**WHEREAS**, the Approved Budget for the Contract (ABC) is Pesos: Four Million Four Hundred Seven Thousand Five Hundred Fifty and 00/100 (Php 4,407,550.00), inclusive of all applicable taxes and fees, to be completed within six (6) months and twenty (20) days;

**WHEREAS**, on 11 November 2017, BCDA advertised the Request for Expression of Interest (REI) for said consulting services in the BCDA website, PhilGEPS and in a conspicuous place in the premises of BCDA, continuously for seven (7) calendar days;

**WHEREAS**, in response to the advertisement, TELCOM LIVE CONTENT, INC. and TECHNOVORE SYSTEMS, INC. secured Eligibility Documents for said consulting services;

**WHEREAS**, the above proponents submitted their accomplished eligibility documents before the deadline of submission on 01 December, 2017, 8:00am;

**WHEREAS**, on the same day, at 9:00am, the accomplished eligibility documents of said proponents were opened for Eligibility Check based on the non-discretionary "pass/fail" criterion;

**WHEREAS**, TELCOM LIVE CONTENT, INC. and TECHNOVORE SYSTEMS, INC. passed the Eligibility Check and were evaluated for shortlisting;

**WHEREAS**, the results of evaluation, based on the total minimum score of 70% for shortlisting, are as follows:

**WHEREAS**, based on the above results, TELCOM LIVE CONTENT, INC. and TECHNOVORE SYSTEMS, INC. garnered a total score above the required minimum score of 70% for shortlisting;

**NOW, THEREFORE**, we, the members of the Bids and Awards Committee for Consulting Services, hereby RESOLVE, as it is hereby RESOLVED to:

1. Declare TELCOM LIVE CONTENT, INC. and TECHNOVORE SYSTEMS, INC. as SHORTLISTED and ELIGIBLE to proceed to the next stage of the bidding activity;
2. Issue a Notice of Eligibility to the said proponents thereby inviting them to submit their technical and financial bids; and
3. Recommend to the Executive Vice President the approval of the foregoing findings.
