Due to the stricter measures implemented by BCDA in its premises, in line with the recent government issuances on guidelines to address the alarming increase in the daily number of COVID-19 cases in the country, the Special Bids and Awards Committee (SBAC) for National Fiber Backbone – Phase 1 would like to ensure that preventive efforts and measures are observed during the **Opening of Financial Proposals on 24 March 2021 at 10:00 AM** for the abovementioned project. The bidders or their representatives, and others involved in the said activity are enjoined to comply with the following arrangements:

BIDDERS:

- 1. Only one (1) representative per bidder/Joint Venture/Consortium is allowed inside the BCDA premises to witness the Opening of Financial Proposals.
- 2. The bidders or bidder's representatives are required to accomplish the Health Declaration Form to be provided by the BCDA security personnel before they will be allowed to enter the BCDA premises.
- 3. BCDA security personnel shall conduct a non-contact temperature check on the prospective bidder/representative. Any person with a temperature of 37.5°C and above shall not be allowed to enter the premises.
- 4. The prospective bidders/representatives with travel history from outside of the Philippines for the last three (3) weeks shall not be allowed to attend in person at the venue of the Opening of Financial Proposals.
- 5. The prospective bidders/representatives shall wear their face masks and face shields, and maintain social distancing throughout the Opening of Financial Proposals.
- 6. Finally, prospective bidders/ representatives shall bring their own ball pen for purposes of signing their attendance in the meeting.

OTHER ATTENDEES:

1. The SBAC and Observers from Commission on Audit (COA), BCDA's Internal Audit Service Office (IASO), and other offices/entities shall attend the Opening of Financial Proposals through the zoom link provided below.





- 2. There shall be three (3) SBAC TWG members (BCDA and DICT personnel) who shall be physically present at the venue of the Opening of Financial Proposals to open and conduct preliminary checking of the Financial Proposals.
- 3. There shall be three (3) members of SBAC Secretariat who shall be physically present to assist during the Opening of Financial Proposals and document the said activity.
- 4. There shall be one (1) personnel from BCDA's Public Affairs Department who shall be physically present to document as well the said activity.
- 5. There shall be two (2) personnel from BCDA's ICT Department who shall be physically present to take charge in the Facebook Livestreaming and recording of the said activity via zoom.
