## REVISED TIMETABLE FOR THE DESIGN AND BUILD OF THE NATIONAL ACADEMY OF SPORTS (NAS) PHASE 1 AT NEW CLARK CITY

In view of the current challenges brought about by the COVID-19 pandemic, specifically with the growing number of positive cases in BCDA, the BCDA management imposed a lockdown in all the BCDA offices, including the offices in Clark, Pampanga, beginning March 12, 2021, which thus prevents the members of the Technical Working Group (TWG) of the Special Bids and Awards Committee (SBAC) for the Design and Build of the National Academy for Sports – Phase 1 in NCC to have an access to all the documents related to the bidding at hand. Further, all the members of the TWG are currently undergoing a mandatory quarantine as they become close contacts of those who were tested positive with the COVID-19.
