DECLARATION OF ELIGIBLE AND SHORTLISTED BIDDER

REBIDDING OF CONSULTING SERVICES FOR THE CONSTRUCTION MANAGEMENT AND SUPERVISION (CMS) OF THE DESIGN AND BUILD PROJECT FOR THE NATIONAL ACADEMY OF SPORTS (NAS) - PHASE 1 AT NEW CLARK CITY

WHEREAS, The BCDA, through the 2021 General Appropriations Act (GAA), approved the procurement of the above consulting service with an Approved Budget for the Contract (ABC) in the amount of **Pesos: Twenty Seven Million Nine Hundred Eighty Three Thousand Two Hundred Pesos and 00/100 (PhP 27,983,200.00)**, inclusive of all applicable taxes and fees, to commence upon the receipt of the Notice to Proceed (NTP);

WHEREAS, On 30 April 2021, the Bids and Award Committee for Consulting Services (BAC-C) advertised the Request for Expression of Interest for the **REBIDDING FOR THE CONSULTING SERVICES FOR CONSTRUCTION MANAGEMENT AND SUPERVISION FOR THE NATIONAL ACADEMY OF SPORTS (NAS)- PHASE 1 AT NEW CLARK CITY** in the BCDA Website, PhilGEPS and in a conspicuous place in the premises of BCDA continuously for seven (7) days;

WHEREAS, The procurement of the said services shall be undertaken through competitive bidding using Quality Cost-Based Evaluation (QCBE) procedure with 70% minimum score to be shortlisted:

WHEREAS, On 6 May, 2021 the Bids and Awards Committee for Consulting Services (BAC-C) conducted the Pre-Eligibility Conference and was attended by the following firms:

1. Asyana and Coninco;
2. Filipinas Dravo Corporation (FILDRAVO);
3. IA Campbell & Associates; and
4. Tenman Project Management (TPM).

WHEREAS, In response to the said advertisement, the following bidders responded and secured the Eligibility Documents:

1. Santos Knight Frank, Inc. (SKFI); and
2. Filipinas Dravo Corporation (FILDRAVO);

WHEREAS, The above proponents submitted their accomplished eligibility documents before the deadline of submission on 21 May 2021, 12:00 NN.

WHEREAS, On the same day, at 1:00 PM, the accomplished eligibility document of the proponents were opened and checked based on the non-discretionary "pass/fail" criterion;

WHEREAS, the result of evaluation based on the submitted Eligibility Proposals are as follows:



1. DECLARE Santos Knight Frank, Inc. and Filipinas Dravo Corporation **AS SHORTLISTED and ELIGIBLE** to proceed to the next stage of bidding activities;
2. ISSUE Notice of Eligibility to the said proponent inviting them to bid for the **REBIDDING CONSULTING SERVICES FOR CONSTRUCTION MANAGEMENT AND SUPERVISION OF THE DESIGN AND BUILD PROJECT FOR THE NATIONAL ACADEMY OF SPORTS (NAS) - PHASE 1 AT NEW CLARK CITY** ; and
3. RECOMMEND to the Head of Procuring Entity (HoPE) the approval of the foregoing findings.


