DECLARATION OF HIGHEST RATED BID (HRB)

REBIDDING OF THE CONSULTING SERVICES FOR SUBIC-CLARK RAILWAY PROJECT

WHEREAS, the BCDA Board has approved the procurement of the above services with an Approved Budget for the Contract (ABC) in the amount of Pesos: One Billion Five Hundred Twenty Million Five Hundred Thirty Four Thousand Four Hundred Pesos (₱1,520,534,400.00), inclusive of any and all applicable taxes, fees and incidental expenses;

WHEREAS, On 3 November 2020, the Bids and Awards Committee for Consulting Services (BAC-C) advertised the Request for Expression of Interest for the REBIDDING FOR THE CONSULTING SERVICES FOR SUBIC-CLARK RAILWAY PROJECT in a newspaper of general nationwide circulation, BCDA Website, PhilGEPS website and in a conspicuous place in the premises of BCDA continuously for seven (7) days;

WHEREAS, On 20 November 2020, the Bids and Awards Committee for Consulting Services (BAC-C) issued **BAC-C RESOLUTION NO. BC2020-0032**, declaring the following bidders as SHORTLISTED and ELIGIBLE to proceed to the next stage of the bidding process:

- a. EGIS Rail PTE Sg and T&D Consult;
- b. DESIGN SCIENCE INCORPORATED (PRINCIPAL) IN JOINT VENTURE WITH BONIFICA S.P.A, TCGI ENGINEERS, PHILIPPS TECHNICAL CONSULTANT CORPORATION AND FILIPINAS DRAVO CORPORATION-Design Science , Inc. JV (BSPA, TCGI, Philips & Fildravo);
- c. THE CONSORTIUM OF AECOM SINGAPORE PTE. LTD AND PROJECTS DESIGN PLUS ARCHITECTURE MANAGEMENT CORP.; and
- d. JOINT VENTURE OF SYSTRA S.A. (LEAD); SYSTRA PHILIPPINES INCORPORATED (SPI); KE ASIA INCORPORATED (KEA); DCCD ENGINEERING CORPORATION (DCCD) AND ENGINEERING AND DEVELOPMENT CORPORATION OF THE PHILIPPINES (EDCOP) (SKED JV)- SKED JV (SPI-SSA-KEA-EDCOP-DCCD).

WHEREAS, On 14 December 2020, the above-mentioned bidders, except for the SKED JV (SPI-SSA-KEA-EDCOP-DCCD), purchased bid documents and submitted their Technical and Financial Proposal before the deadline at 2:00PM

WHEREAS, the evaluation procedure adopted to be declared as the bidder with Highest Rated Bid (HRB) was the Quality-Cost Based Evaluation (QCBE) procedure. The consultant must pass the required 70% minimum technical score;

WHEREAS, On 14 December 2020, at 3:00PM, the Technical Proposal of each bidder was opened and the BAC conducted preliminary technical evaluation.

WHEREAS, The TWG conducted the evaluation of technical proposals based on the approved detailed evaluation criteria. The consolidated results of the technical evaluation are as follows:

WHEREAS, The three (3) bidders attained a total technical score above the required minimum technical score of 70% and were considered qualified to proceed with the opening of financial proposals.

WHEREAS, On 17 December 2020, the financial proposal of each bidder was opened. Immediately after the opening, the TWG conducted the evaluation of their financial proposals. Below is the result of the financial evaluation:

2. PROCEED with the negotiations and undergo post qualification of said bidder in accordance with Section 32.2.5 and Sec. 34 of the IRR of RA 9184, respectively.




