DECLARATION OF HIGHEST RATED AND RESPONSIVE BID (HRRB)

REBIDDING OF THE CONSULTING SERVICES FOR SUBIC-CLARK RAILWAY PROJECT

WHEREAS, the BCDA Board has approved the procurement of the above services with an Approved Budget for the Contract (ABC) in the amount of Pesos: One Billion Five Hundred Twenty Million Five Hundred Thirty Four Thousand Four Hundred Pesos (₱1,520,534,400.00), inclusive of any and all applicable taxes, fees and incidental expenses;

WHEREAS, On 3 November 2020, the Bids and Awards Committee for Consulting Services (BAC-C) advertised the Request for Expression of Interest for the REBIDDING FOR THE CONSULTING SERVICES FOR SUBIC-CLARK RAILWAY PROJECT in a newspaper of general nationwide circulation, BCDA Website, PhilGEPS website and in a conspicuous place in the premises of BCDA continuously for seven (7) days;

WHEREAS, Pursuant to the approved BAC-C Resolution No. BC2020-045 dated 21 December 2020, the Joint Venture of Consortium of AECOM SG and Projects Design Plus Architecture Management Corp. was declared as the Highest Rated Bid (HRB) for the REBIDDING OF THE CONSULTING SERVICES FOR SUBIC-CLARK RAILWAY PROJECT. Likewise, the said resolution resolved to proceed with the negotiation with the HRB;

WHEREAS, Negotiation with the HRB was conducted on 29 December 2020, pursuant to Section 33.2.5 of the revised IRR of RA 9184.

WHEREAS, after the conduct of successful negotiation, pursuant further to RA 9184 revised IRR, the Technical Working Group (TWG) conducted post-qualification activities on 29 December, 2020 and 4-6 January, 2021 to verify, validate and ascertain all statements made and the documents submitted by the HRB;

WHEREAS, To ensure completion of all pertinent post-qualification activities, BAC-C requested from the HOPE for the extension of the period of post-qualification activities for thirty (30) days in accordance with R.A. 9184. Section 34.8 provides that:

“The post-qualification process shall be completed in not more than twelve (12) calendar days from the determination of the Lowest Calculated Bid/Highest Rated Bid. In exceptional cases, the post-qualification period may be extended by the HOPE, but in no case shall the aggregate period exceed forty-five (45) calendar days for Goods and Infrastructure Projects, or thirty (30) calendar days in Consulting Services.”

WHEREAS, The TWG, upon information of the HOPEs approval of the extension, resumed the conduct of post-qualification activities on 25-27 January 2021.

WHEREAS, the results of the post qualification activities conducted by the TWG are as follows:

1. The official address of the Joint Venture of AECOM SG and Projects Design Plus Architecture Management Corp. at 148 Jupiter Street, Bel Air, Makati City as validated during an ocular visit at the office.
2. Joint Venture of AECOM SG and Projects Design Plus Architecture Management Corp. is compliant with the labor laws such as the latest payment to SSS, PhilHealth, and Pag-ibig Fund, upon verification of original copies of Class A legal documents. Supporting documents for completed and on-going projects were also found to be legitimate.
3. The nominated key personnel have sufficient work experiences as stated in their curriculum vitae based on the conduct of interviews through on-line platforms (google meet/zoom) and phone calls.
4. Previous clients have positive feedback on the performance of Joint Venture of AECOM SG and Projects Design Plus Architecture Management Corp. when verified through videoconferencing phone calls.

WHEREAS, The BACC-TWG members and its provisional members recommended to declare the bid of Joint Venture of AECOM SG and Projects Design Plus Architecture Management Corp. as Highest Rated And Responsive Bid (HRRB).

NOW, THEREFORE, after deliberation and premises considered, we, the members of the Bids and Awards Committee for Consulting Services, hereby RESOLVE, as it is hereby RESOLVED to:

1. DECLARE Joint Venture of Consortium of AECOM SG and Projects Design Plus Architecture Management Corp. as the bidder with the Highest Rated and Responsive Bid (HRRB) for the REBIDDING OF THE CONSULTING SERVICES FOR SUBIC-CLARK RAILWAY PROJECT;
2. AWARD the Contract to Joint Venture of Consortium of AECOM SG and Projects Design Plus Architecture Management Corp. in the amount of Pesos: One Billion One Hundred Sixty Nine Million Nine Hundred Eight Thousand Seven Hundred Twenty Pesos and 00/100 (Php 1,169,908,720.00), inclusive of all applicable taxes and fees; and
3. Require the end user to furnish the BAC-C Secretariat original copies of the duly conformed Notice of Award, Executed Contract and Notice to Proceed.




