

**RESUMPTION OF ALL PROCUREMENT ACTIVITIES UNDER
BIDS AND AWARDS FOR GOODS (BAC-G)
BID BULLETIN NO. BAC-G-ES 2021-002**

I. DECLARATION OF ENHANCED COMMUNITY QUARANTINE (ECQ)

On 30 July 2021, the government declared the implementation of the General Community Quarantine with heightened and additional restrictions effective 30 July - 05 August 2021 and Enhanced Community Quarantine (ECQ) effective 06-20 August 2021 in Metro Manila due to the projected surge of COVID-19 cases with the entry of COVID-19 Delta Variant in the country.

Subsequently, on 06 August 2021, the BCDA Bids and Award Committee for Goods (BAC-G) issued the Bid Bulletin No. BAC-G ES 2021-001 to respond to bidders' queries and to suspend, until further notice, the Submission of Bids and other subsequent bidding activities for the Procurement for Annual Subscription of BCDA Email System.

II. EASING UP OF COMMUNITY QUARANTINE STATUS FROM ECQ TO MECQ

On 19 August 2021, the government declared the implementation of the Modified Enhanced Community Quarantine (MECQ) in Metro Manila, Laguna, and Bataan effective 21-31 August 2021, where the Philippine government eases up the community quarantine restrictions in these affected areas, per the Inter-Agency Task Force (IATF) guidelines. Pursuant to this declaration, BAC-G can now continue and resume its procurement activities.

III. RESUMPTION OF ALL BIDDING ACTIVITIES OF BAC-G

With the government's declaration of a lesser community quarantine restrictions, BAC-G now resumes all its procurement and bidding activities, **effective immediately**.

In connection with the Procurement for Annual Subscription of BCDA Email System, BAC-G already issued its bidding documents, conducted a pre-procurement conference, and issued a bid bulletin for the project, before the Philippine government implemented the ECQ in Metro Manila.

Accordingly, BAC-G resumes the remaining bidding activities for the **Procurement for Annual Subscription of BCDA Email System** with the revised schedule, as follows:
