

BAC-C Resolution No. BC2021-022

ENGAGEMENT OF MEDICAL CONSULTANCY SERVICES

WHEREAS, Bids and Awards Committee for Consultancy (BAC-C) Resolution No. BC 2016-065 dated 22 December 2016 was approved recommending the engagement of Dr. Faith M. Reyes as an individual consultant for medical services with a monthly professional fee of Pesos: Seventy Five Thousand and 00/100 (Php75,000.00), inclusive of all applicable taxes and fees, for six (6) months, renewable at the option of the President and CEO, but in no case shall exceed his term;

WHEREAS, said engagement was through Negotiated Procurement under Section 53.7 Highly Technical Consultants, whose consulting services are primarily confidential and policy determining, where trust and confidence are the primary consideration;

WHEREAS, the contract of Dr. Reyes shall expire on 30 June 2021, and on 07 June 2021, the President and CEO approved the Individual Consultancy Contract, for six (6) months, renewable at the option of the President and CEO, with a monthly rate of Pesos: One Hundred Thousand and 00/100 (Php100,000.00), inclusive of all applicable taxes and fees, effective 01 July 2021;

WHEREAS, the Human Resource Management Department (HRMD), in its letter dated 30 June 2021, affirms that Dr. Reyes is a highly qualified and trained medical practitioner, having served for more than twenty (20) years, has built a close relationship with HRMD and BCDA employees in general, which ensures freedom of discussion, without fear of embarrassment or misgivings of possible betrayal or personal trust on confidential matters, especially on health and well-being of BCDA personnel;

WHEREAS, further to HRMDs affirmation on Dr. Reyes' qualifications, her expertise has been crucial since the start of the pandemic in addressing COVID-19 related issues and concerns and has been very instrumental in the formulation and issuance of various COVID-19 related BCDA policy guidelines. Dr. Reyes also continues to play a very critical role in providing vital information and medical advice to top management in relation to the overall health and well-being of the entire BCDA workforce;

NOW, THEREFORE, the BAC-C resolve, as it is hereby resolved:

1. To recommend the engagement of Medical Services of Dr. Faith M. Reyes under Section 53.7 Highly Technical Consultants of the Revised IRR of RA 9184, for six (6) months, renewable at the option of the President and CEO, with a monthly rate of Pesos: One Hundred Thousand and 00/100 (Php100,000.00), inclusive of all applicable taxes and fees;
2. To recommend the issuance of the Notice of Award to Dr. Faith M. Reyes for the engagement of medical consultancy services; and

3. To direct the end-user to furnish the BAC-C copies of the duly conformed Notice to Proceed, as well as the executed contract for the Engagement of Medical Consultancy Services.
