### PROCUREMENT OF OPERATION AND MAINTENANCE SERVICES FOR THE NEW CLARK CITY SPORTS COMPLEX, NCC, TARLAC

## RESOLUTION NO. BG-OM-2021-001 (FAILURE OF BIDDING)

WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA) has bid out the Procurement of Operation and Maintenance Services for the New Clark City Sports Complex, NCC, Tarlac with the Approved Budget for the Contract (ABC) in the amount of One Hundred Three Million Pesos and 00/100 (Php103,000,000.00), inclusive of all applicable government taxes and fees, through the General Appropriations Act (GAA);

**WHEREAS**, the Bids and Awards Committee for Goods (BAC-G), through its Secretariat, advertised the Invitation to Bid on 10 June 2021 in the following:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, the BAC-G issued the Bid Bulletin No. BG-OM-2021-001 dated 25 June 2021 to respond to queries raised during the pre-bid conference and sent through email. Subsequently, the BAC-G issued the Bid Bulletin No. BG-OM-2021-002 on 06 July 2021 and Bid Bulletin No. BG-OM-2021-003 on 12 July 2021 to provide responses for the additional queries by the interested bidders and give them ample time in preparation for their bid proposals;

**WHEREAS**, in response to the said advertisements, the following private companies, submitted their bids before the deadline for submission of bids;

- a. Jones Lang Lasalle Phils., Inc.;
- b. Philjaya Property Management Corporation; and
- c. Santos Knight Frank, Inc.

**WHEREAS**, during the Opening of Bids on 21 July 2021, the BAC-G opened the bidding documents of the above-mentioned bidder. During the opening of the eligibility requirements and technical documents, the BAC-G observed the following:

All three (3) bidders have failed to submit the required eligibility and technical documents per the prescribed Bidding Documents and Bid Bulletins issued for the project, therefore, their financial proposals have been left unopened, pursuant to the RIRR of RA 9184;

The Abstract of Bids is hereby attached as "Annex "A".

**WHEREAS**, during its meeting on 27 July 2021, BAC-G has declared all the bidders as **disqualified and ineligible** for not complying with the prescribed Bidding Documents. As a result, BAC-G has declared a failure of bidding for this project, pursuant to Section 35.1 of the Revised IRR of Republic Act No. 9184, to wit;







#### "35.1. The BAC shall declare the bidding a failure when:

- 1) XXX;
- 2) XXX;
- 3) **All bids fail to comply with all the bid requirements** or fail post-qualification, XXX"

WHEREAS, Philjaya Property Management Corp. (Philjaya) and Jones Lang Lasalle Phils. (JLL), Inc. have both submitted separately their Motions for Reconsideration (MR) requesting BAC-G to reconsider its decision in declaring both of them disqualified and ineligible for their failure to submit some required eligibility and technical requirements, against the prescribed Bidding Documents and Bid Bulletins issued for the project;

**WHEREAS**, BAC-G denied the MR of Philjaya Property Management Corp. through a letter dated 28 July 2021 stating that Philjaya is **ineligible** due to its failure to submit, as part of the technical documents, the Property Accountant position being part of the Maintenance Personnel per the Technical Specifications, based on the Bid Bulletin No. BG-OM-2021-002 issued for the project;

WHEREAS, BAC-G denied the MR of JLL through a letter dated 28 July 2021 stating that JLL is **ineligible** due to its failure to submit, as part of its technical documents, the required 1) Single Largest Completed Contract (SLCC) and 2) nominated Facilities Manager per the Technical Specifications for the project;

**NOW, THEREFORE**, we, the Members of the Bids and Awards Committee for Goods, hereby **RESOLVE** as it is hereby **RESOLVED** to recommend the following:

- a. To declare a Failure of Bidding for the **Procurement of Operation and Maintenance Services for the New Clark City Sports Complex, NCC, Tarlac**; and
- b. To direct the end-user, Procurement and Property Management Department (PPMD), to conduct a mandatory review and evaluation of the terms, conditions, and specifications of the Bidding Documents, including its cost estimates, and other requirements for the Procurement of Operation and Maintenance Services for the New Clark City Sports Complex, NCC, Tarlac, pursuant to Section 35.2 of the RIRR of RA 9184.
