WHEREAS, in response to the said advertisements, CT Link Systems, Inc., bought the bid documents for Lot A;

WHEREAS, on the scheduled Opening of Bids on 16 December 2021, CT Link Systems, Inc., submitted bid proposal for Lot A;

WHEREAS, **CT Link Systems, Inc.**, having submitted the required eligibility documents, was declared "eligible" for Lot A of the project, thus, its financial proposal was opened;

WHEREAS, CT Link Systems, Inc., the single "eligible" bidder, submitted the financial bid of Php2,025,000.00, inclusive of all applicable taxes and fees, for Lot A. The Detailed Bid Evaluation Report is hereto attached as *Annex "A"*;

WHEREAS, on 22-23 December 2021, the Technical Working Group of BAC-G (BAC-G TWG) conducted post qualification of CT Link Systems, Inc., to determine whether it complies with, and is responsive to the requirements and conditions specified in the Bidding Documents;

WHEREAS, after the conduct of post-qualification, careful examination, validation, and verification of all the eligibility, technical and financial documents submitted by **CT Link Systems, Inc.,** BAC-G declared its bid proposal for Lot A as Complying and Responsive. The Copy of Post Qualification Report is hereto attached as **Annex "B"**;

NOW, THEREFORE, foregoing premises considered, we, the members of the **BAC-G**, hereby **RESOLVE**, as it is hereby resolved, to recommend the following:

- 3. To issue the corresponding Notice of Award to CT Link Systems, Inc.; and
- 4. To direct the **Information and Communications Technology Department (ICTD)**, being the end-user unit, to furnish the **BAC-G** copies of the **duly conformed Notice of Award** and **Notice to Proceed**, and the **duly executed agreement/contract**.

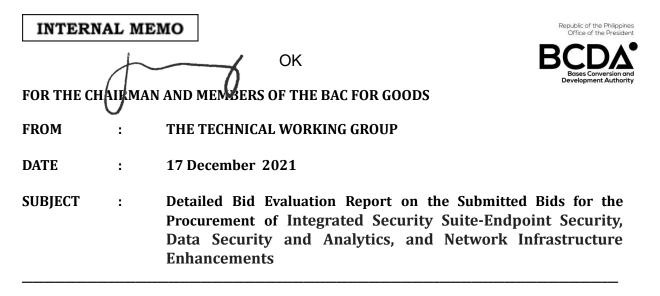

I. Reference.

Pursuant to Section 32.2.1 of the Revised Implementing Rules and Regulations of Republic Act No. 9184, the Technical Working Group (TWG) of the Bids and Awards Committee for Goods (BAC-G) conducted a detailed evaluation of the submitted bid by first, determining the eligibility of the participating bidders through their submitted documents and second, determining the Lowest Calculated Bid considering both completeness of bid and arithmetical correction of submitted financial bids.

II. Background

On 16 December 2021, BAC-G conducted the Opening of Bids for the **Procurement of Integrated Security Suite-Endpoint Security, Data Security and Analytics, and Network Infrastructure Enhancements**. Two (2) bidders submitted bidding proposal on the said procurement, namely:

- 1. KOLLAB Guru Group Inc. for Lot B; and
- 2. CT Link Systems, Inc. for Lot A and B

No bid was received for Lot C, thus, it was declared as a failed bidding.

The eligibility and technical documents submitted by bidders were opened to determine their compliance with the requirements of the project for each Lot.

KOLLAB Guru Group Inc., PASSED all the required eligibility and technical components for **Lot B - Data Security and Analytics**, and found to be **Eligible**. Thus, its financial proposal was opened and found to be within the Approved Budget for the Contract (ABC) for Lot B.

CT Link Systems, Inc., PASSED all the required eligibility and technical components for **Lot A - Annual Subscription of the Integrated Security Suite - Endpoint Security,** thus, its financial proposal was opened and found to be within the approved budget for the contract (ABC) for Lot A.

However, **CT Link Systems, Inc.** failed to submit all mandatory requirements for **Lot B**, under the Technical Specifications, thus, **CT Link Systems, Inc.** was declared Ineligible and its financial bid proposal envelope for Lot B was kept unopened.

III. Findings.

The Bid Documents of the two eligible bidders were further evaluated to determine the Lowest Calculated Bid, as required in the RIRR of RA 9184.

- 2. To declare KOLLAB Guru Group Inc. as the Single Calculated Bidder (SCB) for the Procurement of Integrated Security Suite-Endpoint Security, Data Security and Analytics, and Network Infrastructure Enhancements -Lot B, with the financial proposal amounting to Four Million Four Hundred Ninety One Thousand Six Hundred Forty Three Pesos and 52/100 Only (Php 4,491,643.52), inclusive of VAT and all applicable taxes and fees; and
- 3. To conduct post-qualification with **CT Link Systems, Inc.** for **Lot A** and **KOLLAB Guru Group Inc.** for **Lot B** pursuant to RIRR of RA 9184.

- 3. To declare **KOLLAB Guru Group Inc** as the Single Calculated and Responsive Bidder (SCRB) for the **Integrated Security Suite-Endpoint Security, Data Security and Analytics, and Network Infrastructure Enhancement- LOT B** ; and
- 4. To award the contract to KOLLAB Guru Group Inc with the amount of Four Million Four Hundred Ninety One Thousand Six Hundred Forty Three Pesos and 52/100 (Php 4,491,643.52), inclusive of VAT and all applicable taxes and fees for Integrated Security Suite-Endpoint Security, Data Security and Analytics, and Network Infrastructure Enhancement- LOT B.
