


You are therefore required, within ten (10) calendar days from the receipt of this Notice of Award (NOA), to:

c. Surety bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security; or	Thirty percent (30%)
d. Any combination of the foregoing.	Proportionate to share of form with respect to total amount of security
