**PROCUREMENT OF LOGISTICAL REQUIREMENTS FOR ATHLETES VILLAGE AS  
COVID-19 QUARANTINE FACILITY IN REGION III**

**RESOLUTION NO. BACG-QF-2022-001**

**WHEREAS**, in line with the National Action Plan for COVID-19 pandemic and in conformity with Inter-Agency Task Force for the Management of Emerging Infectious Disease (IATF-EID) Resolution No. 16 (dated 27 March 2020), the government directed all local government units (LGUs) and government-owned and controlled corporations (GOCCs) to identify their respective government facilities that may be temporarily converted into isolation or quarantine facilities against COVID-19 pandemic in the country;

**WHEREAS**, in the 30 March 2020 letter of the Inter-Agency Task Force for the Management of Emerging Infectious Disease (IATF-EID) to BCDA, the IATF-EID approved the utilization of identified facilities within New Clark City (NCC) and the Clark Freeport Zone into temporary isolation, quarantine, and medical treatment facilities to accommodate suspected, probable, and confirmed cases of COVID-19.

**WHEREAS**, in 2020 and 2021, in line with the National Action Plan for COVID-19 pandemic and in conformity with the Inter-Agency Task Force Resolution No. 16 (30 March 2020), "Additional Guidelines for the Enhanced Community Quarantine"; pursuant to GPPB Resolution No. 03-2020, "Approving the Adoption of Efficient, Effective and Expedient Procurement Procedures during a State of Public Health Emergency"; and related issuances, BCDA had identified and utilized facilities in NCC to quarantine and isolate confirmed positive COVID-19 patients, Returning Overseas Filipinos (ROFs), and Health Care Workers (HCWs), from NCR, Region III, and surrounding regions;

**WHEREAS**, BCDA closed the Athletes' Village as a quarantine and isolation facility for COVID-19 related activities on 31 December 2021;

**WHEREAS**, due to the recent surge of COVID-19 cases, BCDA is being called again and requested by the IATF-EID, through the Office of the Civil Defense (OCD), to immediately reactivate the Athletes Village to augment the isolation capacity in Region III;

**WHEREAS**, in the 12 January 2022 letter to OCD, the IATF-EID requested OCD to immediately reactivate the Athlete's Village at New Clark City, Tarlac with the following details to augment the isolation capacity in Region III:

The IATF-EID also requested OCD to provide the budget covering the maintenance services of the facility (including laundry services), utilities, drinking water, and food for the admitted COVID-19 positive patients, Returning Overseas Filipinos (ROFs), Health Care Workers, and non-medical personnel. The use of the rooms at the Athletes' Village is free of charge since it is a government-owned facility. Moreover, the Bureau of Quarantine (BOQ), under Oplan Kalinga program, shall manage the facility while it is being used as an isolation and a quarantine facility from January to March 2022;

**WHEREAS**, in the 14 January 2022 letter to BCDA, the National Task Force against COVID-19 National Incident Command – Emergency Operations Center (NIC-EOC) requested BCDA to allow Oplan Kalinga, through OCD, to use the Athlete's Village as a quarantine and isolation facility as early as 16 January 2022 to admit positive COVID-19 patients.

**WHEREAS**, on 26 January 2022, the BCDA Board approved the following:

1. BCDA to enter into a contract with the OCD and service providers through Section 53.2 (Emergency Case Procurement) of Republic Act (RA) No. 9184 and its Revised Implementing Rules and Regulations (RIRR); Government Procurement and Policy Board (GPPB) Resolution No. 03-2020 "approving the adoption of efficient, effective and expedient procurement procedures during a state of Public Health Emergency"; and Appendix 21 of the 2016 Revised Implementing Rules and Regulations of the Republic Act No. 9184;
2. Supplemental budget of **Php45,197,900.00** to finance the logistical requirements of the quarantine facility;
3. Inclusion of the supplemental budget in the 2022 Annual Procurement Plan (APP); and
4. Authority of the Officer-in-charge (OIC)-PCEO or in his absence, the Executive Vice President (EVP), to sign the contract, for and in behalf of BCDA, and other documents necessary for the implementation of this project;

**WHEREAS**, in the 31 January 2022 Memo to the Bids and Awards Committee (BAC-G), the end-user, Procurement and Property Management Department (PPMD), requested the BAC-G to enter into contracts with the service providers of logistical requirements for its operation [i.e., catering, laundry, garbage collection, utilities (water and power), and supply of drinking water] pursuant to Section 53.2 (Emergency Case Procurement) of Republic Act (RA) No. 9184 and its RIRR, GPPB Resolution No. 03- 2020, and Appendix 21 of the 2016 RIRR of RA 9184. Moreover, the end-user also requested the BAC-G to delegate to PPMD the authority to directly negotiate and/or conduct emergency procurement activities pursuant to Republic Act No. 9184 and its RIRR; and GPPB Resolution No. 03-2020.

**WHEREAS**, BAC-G has approved to delegate the procurement of the logistical requirements such as food/catering services, supply of drinking water, and laundry services for the Athletes'

Village while it is being used a quarantine facility, pursuant to GPPB Resolution No. 03-2020, to quote:

*“(3) Authorize the HOPE to delegate to either the BAC or to the end-user unit or any other appropriate bureau, committee, support or procuring unit the authority to directly negotiate with legally, technically, and financially capable supplier, contractor, or consultant for procurement undertaken through any of the allowable instances of Negotiated Procurement (Emergency Cases) under Section 53.2 of the 2016 RIRR and Item V(D)(2a) of Annex “H” of the same IRR;*

*(4) Allow the HOPE to delegate the awarding of the contract under Negotiated Procurement (Emergency Cases) under Section 53.2 of the 2016 RIRR Xxxx;*

*(5) Include in the Procurement Projects that may be covered by Negotiated Procurement (Emergency Cases) under Section 53.2 of the 2016 RIRR and Item V(D)(2a) of Annex “H” of the same IRR the lease of property or venue for the use as quarantine centers, evacuation sites, medical relief and aid distribution locations, Xxxx.”*


**NOW, THEREFORE**, foregoing premises considered, we, the members of the **BAC-G**, hereby **RESOLVE**, as it is hereby resolved, to recommend the following:

1. To delegate the authority to the end-user, PPMD, to directly negotiate and/or conduct emergency procurement activities related to the maintenance and **Logistical Requirements of Athletes Village as COVID-19 Quarantine Facility in Region III** (supply of drinking water, laundry services, and food provision/catering services), pursuant to Republic Act No. 9184 and its RIRR and GPPB Resolution No. 03-2020; and
2. To direct the **PPMD**, being the end-user unit, to furnish the **BAC-G** copies of the **duly conformed Notice of Award** and **Notice to Proceed**, and the **duly executed agreement/contract** for this project within the prescribed time.
