I. Preliminary Statement:

This pertains to your 27 January 2020 letter requesting for our review and comments on the draft Contract for Consulting Services for the Construction Management and Supervision of the Special and Technical Staff (STS) Building for the Special Service Center (SSC) and Division Administrative Command Center (DACC) (Contract) in Fort Bonifacio, Taguig City, prior to bidding and execution.

Apart from the draft Contract, you likewise submitted the General Conditions of the Contract (GCC), the Special Conditions of the Contract (SCC) and the Terms of Reference (TOR). You manifested that the Contract, GCC and SCC were all patterned after the Philippine Bidding Documents pro-forma templates for consulting services.

II. Antecedents:

By way of background, Republic Act (R.A.) 7227, otherwise known as the "Bases Conversion and Development Act of 1992", as amended, transferred the ownership of certain portions of Fort Bonifacio in Taguig City to the BCDA for development and disposition, in order to raise funds for the Department of National Defense/Armed Forces of the Philippines (DND/AFP) Modernization Program, as well as for the development of other former US Military Bases into alternative productive civilian uses.

You disclosed that in order to develop Fort Bonifacio, the STS Building for the SSC and DACC of the Philippine Army has to be relocated and replicated in Fort Bonifacio, Taguig City.

BCDA is in the process of procuring the consulting services for the construction management and supervision of the STS Building through public bidding and the draft Contract will be used as template.

Thus, BCDA is now seeking the review and approval of the Contract, prior to execution.

III. Discussion:

A perusal of the SCC and GCC of the Contract shows that it follows the template provided in the Philippine Bidding Documents for the Procurement of Consulting Services.

After a careful study of its terms and conditions, and subject to BCDA's due compliance with the provisions of RA 9184, its 2016 Revised Implementing Rules and Regulations (RIRR) and other relevant laws, we find the draft Contract to be generally in order and its provisions amply protective of BCDA's legal interest, subject to the following comments and suggested revisions:



1. Revise the first paragraph of the ANTECEDENTS as follows:

- 2. Aside from the documents enumerated under item 2 of the body of the Contract, it is suggested that the Bids and Awards Committee (BAC) Resolution recommending the winning bidder be also made an attachment.
- 3. BCDA is further advised to make sure that the Performance Security is sufficient and posted, accordingly.
- 4. Insofar as item 18.3 of the SCC is concerned, BCDA should ensure that the details of the account of the winning bidder are indicated prior to signing.
- 5. Under item 34.2 of the GCC, it is indicated that disputes arising from the implementation of the Contract shall be submitted to arbitration in accordance with the rules of procedure indicated in the SCC. Considering that the SCC is silent on this matter, we recommend that this be specified either in the SCC or the Contract.

It is further suggested that a provision stipulating an exclusive venue be added in the event of court litigation.

6. All blank spaces and unsupplied data should be filled out before the final draft Contract is finalized and executed.



7. All the necessary annexes mentioned in the final draft Contract must be attached in its final form.

IV. Conclusion:

Subject to the foregoing comments and suggested revisions, and BCDA's due compliance with the provisions of RA 9184, its 2016 RIRR and other relevant laws, the draft Contract may be given due course.

This review, however, did not pass upon the financial and technical aspects of the Contract nor the propriety or necessity of executing the same since these are matters best addressed to BCDA management's sound business judgment.
