

CONTRACT AGREEMENT

This **CONTRACT AGREEMENT**, made this 19th day of April 2021 between

The **BASES CONVERSION AND DEVELOPMENT AUTHORITY**, a government instrumentality vested with corporate powers, created by virtue of Republic Act No. 7227, as amended, with principal office address at the BCDA Corporate Center, 2/F Bonifacio Technology Center, 31st Street corner 2nd Avenue, Bonifacio Global City, Taguig City, Philippines, represented by its President and CEO, **VIVENCIO B. DIZON** (hereinafter called the "Entity");

and

The **CONSORTIUM OF AECOM SINGAPORE PRIVATE LIMITED AND PROJECTS DESIGN PLUS ARCHITECTURE MANAGEMENT CORPORATION**, with business address at 148 Jupiter Street, Bel-Air, Makati City, Philippines, represented by its Authorized Representative, **MARY LOUISE CATHERINE S. SALDAÑA** (hereinafter called the "Consultant").

WHEREAS, the Entity is desirous that the Consultant execute the Consulting Services for the Subic-Clark Railway Project (SCRP) (hereinafter called "the Works") and the Entity has accepted the bid for **One Billion One Hundred Sixty Nine Million Nine Hundred Eight Thousand Seven Hundred Twenty Pesos and 00/100 (P1,169,908,720.00)** by the Consultant for the execution and completion of such Consulting Services and the remedying of any defects therein.


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached (and contained in the accompanying USB drive), deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) General and Special Conditions of Contract;
 - (b) Terms of Reference;
 - (c) Request for Expression of Interest;
 - (d) Instructions to Bidders, Bid Data Sheet, and Appendices;
 - (e) Bid Bulletin Nos. 1 and 2;
 - (f) Bidding Documents of Consortium of AECOM Singapore Pte. Ltd. and Projects Design Plus Architecture Management Corp.;
 - (g) Eligibility Documents of Consortium of AECOM Singapore Pte. Ltd. and Projects Design Plus Architecture Management Corp.;
 - (h) BACC Resolution No. BC2020-045;

- (i) Agreement during Negotiation between BCDA and Consortium of AECOM Singapore Pte. Ltd. and Projects Design Plus Architecture Management Corp.;
 - (j) Performance Bond;
 - (k) Notice of Award of Contract and the Bidder's conforme thereto; and
 - (l) Joint Venture Agreement of AECOM Singapore Pte. Ltd. and Projects Design Plus Architecture Management Corp.
3. In consideration of the payments to be made by the Entity to the Consultant as hereinafter mentioned, the Consultant hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract Agreement in all respects.
4. The Entity hereby covenants to pay the Consultant in consideration of the execution and completion of the Works and the remedying of any defects therein, the Contract Price or such other sum as may become payable under the provisions of this Contract Agreement at the times and in the manner prescribed by this Contract Agreement.


