**RESOLUTION OF AWARD
(RESO NO. BG-CM 2022-01)**

WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA), through its 2022 Corporate Budget, applied the sum of **Three Million Six Hundred Twenty Thousand Pesos (P3,620,000.00)**, inclusive of VAT and all other applicable government taxes, fees and other charges, as the Approved Budget for the Contract (ABC) for **One (1) Year Rental of Twenty (20) Color Multifunction Copy Machines**;

WHEREAS, the BAC for Goods (BAC-G), through its Secretariat, advertised the Invitation to Bid on 04 February 2022 in the following:

1. DBM Philippine Government Electronic Procurement System (PhilGEPS);
2. BCDA Website; and
3. Conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, in response to said advertisements, only one (1) bidder, **Otus Copy Systems, Inc.**, submitted its bid for the project before the deadline of submission on 01 March 2022 at 09:00 AM;

WHEREAS, during the Opening of Bids on 01 March 2022 at 10:00 AM, BAC-G received and opened the bid from the above-mentioned bidder and noted the following:

WHEREAS, **Otus Copy Systems, Inc.** submitted a financial bid of **Two Million Nine-Hundred Eighty Five Thousand Seven Hundred Ten Pesos and 00/100 (Php2,985,710.00)**, inclusive of all applicable taxes and fees, which is below the ABC. Thus, the BAC-G declared **Otus Copy Systems, Inc.** as the Single Calculated Bid for the project;

WHEREAS, in view of the foregoing and consistent with Section 34 of Rule X – Post-Qualification of the Revised Implementing Rules and Regulations of Republic Act No. 9184, the BAC-G Technical Working Group (TWG) conducted a Post-Qualification with **Otus Copy Systems, Inc.** on 10-14 March 2022 to determine if **Otus Copy Systems, Inc.** is compliant and responsive to the requirements and conditions specified in the Bidding Documents;

WHEREAS, based on results of the post qualification, the TWG found that **Otus Copy Systems, Inc.** is compliant and responsive with the eligibility, technical, and financial requirements of the project;

The Post Qualification Report is hereby attached as **Annex B**.

WHEREAS, on 15 March 2022, BAC-G deliberated the results of the post qualification with **Otus Copy Systems, Inc.** based on the TWG Report, BAC-G found that **Otus Copy Systems, Inc.** is eligible, technically, and financially capable to undertake the project.

ACCORDINGLY, we, the members of the Bids and Awards Committee for Goods, hereby **RESOLVE**, as it is hereby **RESOLVED**:

1. To declare **Otus Copy Systems, Inc.** as the Single Calculated and Responsive Bidder (SCRB) for **One (1) Year Rental of Twenty (20) Color Multifunction Copy Machines**;
2. To award the contract to **Otus Copy Systems, Inc.** with the amount of **Two Million Nine-Hundred Eighty Five Thousand Seven Hundred Ten Pesos and 00/100 (Php2,985,710.00)**, inclusive of VAT and all applicable taxes and fees;
3. To issue the corresponding Notice of Award (NOA) to **Otus Copy Systems, Inc.** (Copy Attached); and
4. To direct the BCDA Information and Communications Technology Department (ICTD), being the end-user unit, to submit to the BAC-G -the duly conformed Notice of Award, Notice to Proceed, and the duly executed agreement/contract.
