Bid Bulletin No. BAC-G-EQ-2022-01	The Bidder must have completed a single contract that is similar to the project, equivalent to at least fifty percent (50%) of the ABC; or at least two (2) similar completed contracts with the aggregate amount equivalent to at least fifty percent (50%) of the ABC and the largest of these similar contracts must be equivalent to at least half of the percentage (25%) of the ABC as required above. The similar contract shall have been completed within <u>six (6) years (April 2016 to April 2022)</u> prior to the date of submission and receipt of bids. (published via	The Bidder must have completed a single contract that is similar to the project, equivalent to at least fifty percent (50%) of the ABC; or at least two (2) similar completed contracts with the aggregate amount equivalent to at least fifty percent (50%) of the ABC and the largest of these similar contracts must be equivalent to at least half of the percentage (25%) of the ABC as required above. The similar contract shall have been completed within <u>ten (10) years (April 2012 to April 2022)</u> prior to the date of submission and receipt of bids.

The above changes further amend the bidding documents, accordingly. The Opening of Bids will be held face-to-face at the BCDA Board Room, 2/F Bonifacio Technology Center, 31st corner 2nd Avenue, Bonifacio Global City, Taguig City , with a video coverage.

Bidders may choose to attend Opening of Bids in person or online via zoom.

For those who are attending in person, the following guidelines must be followed:


- A maximum of two (2) persons per participating bidder are allowed to attend the Opening of Bids and will be required to follow the BCDA Health Protocol for Visitors;
- The representative is required to present his/her vaccination card before he/she can be allowed inside the BCDA office;
- Compliance to social distancing, wearing of face masks, and body temperature screening inside BCDA office must be observed; and
- Observers/representatives who show signs of COVID-19 related symptoms such as cough, flu, fever, high body temperature, and sneezing are advised not to proceed to the BCDA Office since they will not be allowed to enter the BCDA premises.
