This Bid Bulletin clarifies the queries that were raised during the Pre-Bid Conference on 25 March 2022 commenced at 8:00 AM and queries sent through e-mail by prospective bidders, as well as other matters relative to the **Procurement for the Supply, Delivery and Installation of Office and School Equipment for the NAS – Phase 1 at New Clark City**.

I. General Queries

QUERIES	CLARIFICATION/S
1. In the details of our SLCC, it is a mix of Office Machines, Appliances, Audio Visual, Medical Clinic Equipment, Covid19 Prevention Equipment, and Kitchen Equipment. Is it ok if our SLCC is separate for each component like we have for Medical Equipment and we also have for other components? What would be the basis of the SLCC if we have an ABC of P4,955,500?	In the computation of SLCC, we will only compute the cost of the completed similar project i.e. office and school equipment. In this case, Medical Equipment may not be a similar project, therefore, it will be excluded in the computation. The Bidder must have completed a single contract that is similar to the project, equivalent to at least fifty percent (50%) of the ABC; or at least two (2) similar completed contracts with the aggregate amount equivalent to at least fifty percent (50%) of the ABC and the largest of these similar contracts must be equivalent to at least half of the percentage (25%) of the ABC as required above.
