RESOLUTION NO. BG-FF-2022-01

The **BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA)**, through the General Appropriations Act FY 2021 (validity extended pursuant to Republic Act No. 11640) has bid out the **Procurement for the Supply, Delivery and Installation of Furniture and Fixtures for the National Academy of Sports (NAS) – Phase 1 at New Clark City** with an Approved Budget for the Contract (ABC) of **Nine Million Three Hundred Thirty-Eight Thousand Five Hundred Pesos and 00/100 (PhP9,338,500.00)**, inclusive of all applicable taxes and fees;

WHEREAS, the Bids and Awards Committee for Goods (**BAC-G**), through its Secretariat, advertised/posted the Invitation to Bid including the bidding documents on 18 March 2022 in the following:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, BAC-G conducted a Pre-bid Conference on 25 March 2022 which was attended by the following prospective bidders:

- a. ACMI Office Systems Philippines Inc.;
- b. Filcrafters Inc.;
- c. Asahi Design Centre, Inc.;
- d. PenitonTrading;
- e. i3 eSolutions, Inc.;
- f. Aurora Philippines Inc.;
- g. Merit Stainless Steel Inc.;
- h. IGO FURNITURE Makati; and
- i. Dargo Design Component Builders Corporation;

WHEREAS, BAC-G issued Bid Bulletin No. BAC-G-FF-2022-01 dated 05 April 2022 and Bid Bulletin No. BAC-G-FF-2022-02 clarifying queries raised by the prospective bidders during the pre-bid conference and via e-mail. Moreover, BAC-G extended the deadline for the submission of bids from 11 April to 20 April 2022 to provide all interested bidders enough time to prepare their bids for the project;

WHEREAS, in response to said advertisements, two (2) bidders, Asahi Design Centre, Inc. and PenitonTrading, submitted their bids before the deadline on 20 April 2022 at 9:00 AM;

WHEREAS, during the Opening of Bids on 20 April 2022 at 10:00 AM, BAC-G opened the bids from the above-mentioned bidders and noted the following:

WHEREAS, since both bidders are eligible and passed the initial technical requirements, their financial bids were opened, the results of which are shown hereunder:

Based on the submitted eligibility requirements, technical documents, and financial bid, BAC-G declared PenitonTrading as the Lowest Calculated Bidder (LCB) and qualified to undergo the post qualification process;

WHEREAS, consistent with Section 34 of Rule X "Post-Qualification" of the 2016 Revised Implementing Rules and Regulations (2016 RIRR) of RA 9184, the BAC-G Technical Working Group (TWG) conducted the Post-Qualification of PenitonTrading on 02-06 May and 9-11 May 2022;

WHEREAS, on 10 May 2022 BAC-G deliberated the results of the post qualification and found that PenitonTrading is eligible, technically, and financially capable to undertake the project;


ACCORDINGLY, we, the members of the Bids and Awards Committee for Goods, hereby **RESOLVE**, as it is hereby **RESOLVED**:


1. To declare **PenitonTrading** as the Lowest Calculated and Responsive Bidder (LCRB) for **the Supply, Delivery, and Installation of Furniture and Fixtures for the National Academy of Sports (NAS) – Phase 1 at New Clark City**;
2. To award the contract for **the Supply, Delivery, and Installation of Furniture and Fixtures for the National Academy of Sports (NAS) – Phase 1 at New Clark City** to **PenitonTrading** with the amount of **Seven Million Nine Hundred Ninety-Nine Thousand Pesos and 00/100 (Php 7,999,000.00)**, inclusive of VAT and all applicable taxes and fees; and

3. To direct the Special Projects Management Department (SPMD), being the end-user unit, to submit to the BAC-G the duly conformed Notice of Award, Notice to Proceed, and the duly executed agreement/contract during the prescribed period.
