## PROCUREMENT FOR THE SUPPLY, DELIVERY AND INSTALLATION OF ICT EQUIPMENT FOR THE NATIONAL ACADEMY OF SPORTS (NAS) – PHASE 1 AT NEW CLARK CITY

## **RESOLUTION NO. BG-IE-2022-01**

The BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA), through the General Appropriations Act FY 2021 (validity extended pursuant to Republic Act No. 11640) has bid out the Procurement for the Supply, Delivery and Installation of ICT Equipment for the National Academy of Sports (NAS) – Phase 1 at New Clark City with an Approved Budget for the Contract (ABC) of Nine Million Four Hundred Sixty-Nine Thousand Pesos and 00/100 (PhP9,469,000.00), inclusive of all applicable taxes and fees;

**WHEREAS**, the Bids and Awards Committee for Goods (BAC-G), through its Secretariat, advertised/posted the Invitation to Bid including the bidding documents on 18 March 2022 in the following:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

**WHEREAS**, BAC-G conducted a Pre-bid Conference on 25 March 2022 which was attended by the following prospective bidders:

- Microgenesis Business Systems;
- b. Advance Solutions, Inc.;
- c. Quartz Business Products Corporation; and
- d. Trends and Technologies, Inc.

WHEREAS, BAC-G issued Bid Bulletin No. BAC-G-ICT-2022-01 dated 04 April 2022; Bid Bulletin No. BAC-G-ICT-2022-02 dated 08 April 2022; BAC-G-ICT-2022-02 date 11 April 2022 and Bid Bulletin No. BAC-G-ICT-2022-04 dated 13 April 2022 clarifying queries raised by the prospective bidders during the pre-bid conference and subsequently, via e-mail. Moreover, BAC-G extended the deadline for submission of bids from 08 April up to 20 April 2022, through bid bulletins, to provide all interested bidders enough time to prepare their bids for the project;

**WHEREAS**, in response to said advertisements, two (2) bidders, Quartz Business Products Corporation and Advance Solutions, Inc., submitted their bids before the deadline of submission of bids on 20 April 2022;

**WHEREAS**, during the Opening of Bids on 20 April 2022 at 10:00 AM, BAC-G received and opened the bids and noted the following:

**WHEREAS,** since both bidders are eligible and have passed the initial technical requirements, their financial proposals were opened, as shown in the table below:

Based on the submitted financial bid, BAC-G declared Quartz Business Products Corporation as the Lowest Calculated Bid (LCB) and recommended that it undergo a post qualification.

WHEREAS, consistent with Section 34 of Rule X "Post-Qualification" of the 2016 Revised Implementing Rules and Regulations (2016 RIRR) of RA 9184, the BAC-G Technical Working Group (TWG) conducted the Post-Qualification of Quartz Business Products Corporation from 28 April 2022 to 11 May 2022.

**WHEREAS,** BAC-G deliberated the results of the post qualification and found that Quartz Business Products Corporation is eligible, technically, and financially capable to undertake the project;

The Post-Qualification Report is hereby attached as **Annex** "**B**".

**ACCORDINGLY**, we, the members of the Bids and Awards Committee for Goods, hereby **RESOLVE**, as it is hereby **RESOLVED**:

- To declare Quartz Business Products Corporation as the Lowest Calculated and Responsive Bidder (LCRB) for the Supply, Delivery, and Installation of ICT Equipment for the National Academy of Sports (NAS) – Phase 1 at New Clark City;
- To award the contract for the Supply, Delivery, and Installation of ICT Equipment for the National Academy of Sports (NAS) – Phase 1 at New Clark City to Quartz Business Products Corporation for the amount of Seven Million Seven Hundred Sixty-One Thousand Eight Hundred Seventy-Seven Pesos and 00/100 (Php7,761,877.00), inclusive of VAT and all applicable taxes and fees; and







3. To direct the Special Projects Management Department (SPMD), being the end-user unit, to submit to the BAC-G the duly conformed Notice of Award, Notice to Proceed, and the duly executed agreement/contract during the prescribed period.
