**PROCUREMENT FOR THE SUPPLY, DELIVERY AND INSTALLATION OF PHYSICAL THERAPY AND REHABILITATION EQUIPMENT FOR THE NATIONAL ACADEMY OF SPORTS (NAS) – PHASE 1 AT NEW CLARK CITY**

**RESOLUTION NO. BG-PTRE-2022-01**

The **BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA)**, through the General Appropriations Act FY 2021 (validity extended pursuant to Republic Act No. 11640) has bid out the **Procurement for the Supply, Delivery and Installation of Physical Therapy and Rehabilitation Equipment for the National Academy of Sports (NAS) – Phase 1 at New Clark City** with an Approved Budget for the Contract (ABC) of **Six Million Six Hundred Thirty-Nine Thousand Pesos and 00/100 (Php6,639,000.00)**, inclusive of all applicable taxes and fees;

**WHEREAS**, the Bids and Awards Committee for Goods (**BAC-G**), through its Secretariat, advertised/posted the Invitation to Bid including the bidding documents on 18 March 2022 in the following:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

**WHEREAS**, BAC-G has conducted a Pre-bid Conference on 25 March 2022 which was attended by the following prospective bidders:

- a. Rehab Ventures And Medical Products, Inc.;
- b. Quality Medical Trading; and
- c. Lorenzo Commodities Corp.;

**WHEREAS**, BAC-G issued Bid Bulletin No. BAC-G-FTME-2022-01 dated 05 April 2022 and Bid Bulletin No. BAC-G-FTME-2022-02 dated 08 April 2022 clarifying queries raised by the prospective bidders during the pre-bid conference and subsequently, via e-mail;

**WHEREAS**, in response to said advertisements, only (1) bidder, Quality Medical Trading submitted its bid before the deadline on 20 April 2022 at 09:00 AM;

**WHEREAS**, during the Opening of Bids on 20 April 2022 at 10:00 AM, BAC-G opened the bid of the Quality Medical Trading and noted the following;

**WHEREAS**, Quality Medical Trading submitted a financial bid that is below the ABC, amounting to **Six Million Five Hundred Ninety Thousand Pesos and 00/100 (Php6,590,000.00)**, inclusive of all applicable taxes and fees, which is;

**WHEREAS**, in view of the results of the Detailed Evaluation of Bids conducted on 28 April 2022, the BAC-G has declared the bid of **Quality Medical Trading** as ineligible for its failure to comply with the minimum standard requirements per the bidding documents of the project, as shown in the table below:

**WHEREAS**, BAC-G sent Notice of Ineligibility to **Quality Medical Trading** dated 12 May 2022 informing that its bid is found ineligible due to its failure to comply with the minimum standard requirements per our bidding documents for the project, pursuant to the RIRR of RA 9184;

**WHEREAS**, during the BAC-G meeting on 16 May 2022, the BAC-G recommended to declare a failure of bidding for this project, pursuant to Section 35.1 of the RIRR of RA 9184, to wit:

*"35.1 The BAC shall declare the bidding a failure when: XXX b) **All prospective bidders are declared ineligible;** c) **All bids fail to comply with all the bid requirements or fail post-qualification, XXX"***

**ACCORDINGLY**, we, the members of the Bids and Awards Committee for Goods, hereby **RESOLVE**, as it is hereby **RESOLVED**:

1. To declare a Failure of Bidding for the **Procurement for the Supply, Delivery and Installation of Physical Therapy and Rehabilitation Equipment for the National Academy of Sports (NAS) – Phase 1 at New Clark City**; and
2. To direct the end-user, Special Projects Management Department (SPMD) to conduct a mandatory review and evaluation of the terms, conditions, and specifications of the Bidding Documents, including the cost estimates, and other requirements relative to this procurement, pursuant to Section 35.2 of the RIRR of RA 9184;

**RESOLVED**, at the BCDA Corporate Center Office, Bonifacio Global City, Taguig City, this 23 May 2022.
