RESOLUTION NO. BG-FTME-2022-01

The **BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA)**, through the General Appropriations Act FY 2021 (validity extended pursuant to Republic Act No. 11640) has bid out the **Procurement for the Supply, Delivery and Installation of Fitness Testing and Monitoring Equipment for the National Academy of Sports (NAS) – Phase 1 at New Clark City** with an Approved Budget for the Contract (ABC) of **One Million One Hundred Ten Thousand Pesos and 00/100 (Php1,110,000.00)**, inclusive of all applicable taxes and fees;

WHEREAS, the Bids and Awards Committee for Goods (**BAC-G**), through its Secretariat, advertised/posted the Invitation to Bid including the bidding documents on 18 March 2022 in the following:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, BAC-G has conducted a Pre-bid Conference on 25 March 2022 which was attended by the following prospective bidders:

- a. APActive Pro Trading;
- b. Bigway Sports and Fitness Inc.;
- c. Lorenzo Commodities Corp; and
- d. Quality Medical Trading

WHEREAS, BAC-G issued Bid Bulletin No. BAC-G-FTME-2022-01 dated 05 April 2022 and Bid Bulletin No. BAC-G-FTME-2022-02 dated 08 April 2022 clarifying queries raised by the prospective bidders during the pre-bid conference and subsequently, via e-mails. Moreover, BAC-G extended the deadline for submission of bids from 11 April to 20 April 2022, through a bid bulletin, to provide all interested bidders enough time to prepare their bids for the project;

WHEREAS, in response to said advertisements, only one (1) bidder, Quality Medical Trading, submitted its bid before the deadline on 20 April 2022 at 09:00 AM;

WHEREAS, during the Opening of Bids on 20 April 2022 at 10:00 AM, BAC-G opened the bid from Quality Medical Trading and noted the following:

WHEREAS, Quality Medical Trading submitted a financial bid of **One Million Twenty-Four Thousand Pesos and 00/100 (Php1,024,000.00)**, inclusive of all applicable taxes and fees, which is below the ABC. Thus, the BAC-G declared the bid of Quality Medical Trading as the Single Calculated Bid for the project;

WHEREAS, consistent with Section 34 of Rule X "Post-Qualification" of the 2016 Revised Implementing Rules and Regulations (2016 RIRR) of RA 9184, the BAC-G Technical Working Group (TWG) conducted the Post-Qualification of Quality Medical Trading on 02-06 and 09-11 May 2022;

WHEREAS, on 16 May 2022, BAC-G deliberated the results of the post qualification and found that Quality Medical Trading is eligible, technically, and financially capable to undertake the project;

ACCORDINGLY, we, the members of the Bids and Awards Committee for Goods, hereby **RESOLVE**, as it is hereby **RESOLVED**:

1. To declare **Quality Medical Trading** as the Single Calculated and Responsive Bidder (SCRB) for the **Supply, Delivery, and Installation of Fitness Testing and Monitoring Equipment for the National Academy of Sports (NAS) – Phase 1 at New Clark City**;
2. To award the contract for the **Supply, Delivery, and Installation of Fitness Testing and Monitoring Equipment for the National Academy of Sports (NAS) – Phase 1 at New Clark City** to **Quality Medical Trading** for the amount of **One Million Twenty-Four Thousand Pesos and 00/100 (Php1,024,000.00)**, inclusive of VAT and all applicable taxes and fees; and
3. To direct the Special Projects Management Department (SPMD), being the end-user unit, to submit to the BAC-G the duly conformed Notice of Award, Notice to Proceed, and the duly executed agreement/contract during the prescribed period.
