We are pleased to provide further clarifications on the following eligibility requirements for the **Rebidding for the Supply, Delivery and Installation of Electrical Equipment for the NAS – Phase 1 at New Clark City:**

	Queries	Clarification
1.	Can we join the bidding if we have not purchased the bidding documents yet?	BCDA shall only accept bids from those bidders that have paid the applicable fee for the Bidding Documents . Accordingly, pursuant to Sec. 4.3 of Appendix 8 of the 2016 Revised Implementing Rules and Regulations (RIRR) of RA 9184, to wit: "The BAC shall issue the bidding documents to any prospective bidder upon payment of the standard rate of the bidding documents."
2.	Please clarify the cost of bidding documents for this project.	Pursuant to Sec. 5.0 (Standard Rates) of Annex 8 of RIRR of RA 9184, since the Approved Budget for the Contract (ABC) for this project is Php13,000,000.00 , the cost of the bidding documents is Php25,000.00 .
3.	May we request a copy of the Electrical Equipment Layout of the facility.	Yes. Please see attached Annex "A".

Reminders		
Single Largest Completed Contract (SLCC)	The Bidder must have completed a single contract that is similar to the project, equivalent to at least fifty percent (50%) of the ABC; or at least two (2) similar completed contracts with the aggregate amount equivalent to at least fifty percent (50%) of the ABC and the largest of these similar contracts must be equivalent to at least half of the percentage (25%) of the ABC. The similar contract shall have been completed within ten (10) years prior to the date of submission and receipt of bid. For this purpose, contracts similar	
	 to the Project shall be: 1. Contracts for the Supply, Delivery and Installation of Electrical Equipment; and/or 2. Contracts for the Supply, delivery and Installation of mechanical equipment. 	
Financial Component	Original of duly signed and accomplished Financial Bid Form; <u>and</u> Original of duly signed and accomplished <u>Price Schedule</u> . Note: The Bidder must submit cost breakdown (price for each line item) and the total amount should not exceed the Approved Budget for the Contract (ABC) for the Project	





offered and/OR <u>Certificate from the Manufacturer,</u> certifying compliance in	Product Brochure OR Manufacturer's Certificate	It is <u>required</u> that the Bidders submit <u>Product Brochures and/or other related</u> <u>documents</u> containing the description and specifications of each item to be offered and/ <u>OR</u> <u>Certificate from the Manufacturer</u> , certifying compliance in all the specifications of each item to be offered as part of their technical envelope during opening of bids

The Opening of Bids will be held face-to-face at the BCDA Board Room, 2/F Bonifacio Technology Center, 31st street corner 2nd Avenue, Bonifacio Global City, Taguig City, with a video coverage. Bidders may choose to attend Opening of Bids in person or online via zoom.

For those who are attending in person, the following guidelines must be followed:

- A maximum of two (2) persons per participating bidder are allowed to attend the Opening of Bids and will be required to follow the BCDA Health Protocol for Visitors;
- The representative is required to present his/her vaccination card before he/she can be allowed inside the BCDA office;
- Compliance to social distancing, wearing of face masks, and body temperature screening inside BCDA office must be observed; and
- Observers/representatives who show signs of COVID-19 related symptoms such as cough, flu, fever, high body temperature, and sneezing are advised not to proceed to the BCDA Office since they will not be allowed to enter the BCDA premises.
