

Construction of Two (2) Units Deep Well at Wallace Air Station, San Fernando La Union

CONTRACT AGREEMENT

THIS AGREEMENT, made this _____ day of 03 FEB 2022, _____ between **BASES CONVERSION AND DEVELOPMENT AUTHORITY**, with principal office address at the BCDA Corporate Center, 2nd Floor Bonifacio Global Center, 31st Street Corner 2nd Avenue, Bonifacio Global City, Taguig City (hereinafter called the "Entity")

-and-

JASHV CONSTRUCTION AND SUPPLY, with principal office address at Paramount Village, Bumagao Road, Sto. Tomas Proper, Baguio City (hereinafter called the "Contractor")

WHEREAS, the Entity is desirous that the Contractor execute the Construction of Two (2) Units Deep Well at Wallace Air Station, San Fernando La Union (hereinafter called "the Works") and the Entity has accepted the Bid for **Pesos: Fourteen Million Three Hundred Forty-Two Thousand Six Hundred Seven and 69/100 (Php 14,342,607.69)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and

- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
- 3. In consideration for the sum of **Pesos: Fourteen Million Three Hundred Forty-Two Thousand Six Hundred Seven and 69/100 (Php 14,342,607.69)** agrees to undertake the Construction of Two (2) Units Deep Well at Wallace Air Station, San Fernando La Union in accordance with his/her/its Bid.
- 4. The Bases Conversion and Development Authority agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
- 5. Any amendment, modification or additional terms and conditions to this Contract shall be made in writing and executed with the same formalities hereof, provided that such amendment, modifications, or changes do not alter the basic parameters, financial and/or technical terms and conditions of the Agreement.
