## CONTRACT AGREEMENT

The BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA), a government instrumentality vested with corporate powers, created by virtue of Republic Act No. 7227, as amended, with the principal office address at the BCDA Corporate Center, 2/F Bonifacio Technology Center, 31<sup>st</sup> Street corner 2<sup>nd</sup> Avenue, Bonifacio Global City, Taguig City, represented herein by its President and CEO, AILEEN ANUNCIACION R. ZOSA, duly authorized for this purpose as evidence by BCDA Secretary's Certificate dated 22 August 2022, a copy of which is hereto attached as *Annex A*;

- and -

CAVDEAL - CAVITE IDEAL INTERNATIONAL CONSTRUCTION AND DEVELOPMENT CORPORATION AND CREDIBUILD DEVELOPMENT CORPORATION JOINT VENTURE, a Joint Venture du'y organized and existing under the laws of the Republic of the Philippines, with office address at 408 TDS Building, 72 Kamias Road Brgy East Kamias, Quezon City, represented herein by ARON GINO L. EQUIPAJE, Authorized Managing Officer and duly authorized representative for this purpose as evidenced by a Joint Resolution dated 15 November 2021, which is hereto attached as Annex B.

BCDA and Contractor shall hereinafter be referred to, individually, as Party or, collectively, as Parties.

## ANT& CEDENTS

WHEREAS, the BCDA has determined that negctiated procurement of an adjacent and contiguous contract was the most suitable for addressing the urgent need for access roads and other related works, following the provisions and requirements of the IRR of RA 9184. After a thorough evaluation, validation, and verification, it was found that the Contractor is competent and qualified to construct the Works required by the BCDA.

WHEREAS, the BCDA is desirous that the Contractor execute the Construction of

Access Road, Drainage, and Earthworks at Morong Discovery Park, Morong, Bataan (hereinafter called the Works) and the BCDA has accepted the proposal **Two Hundred Forty Six Million**, **Three Hundred Fifty Six Thousand**, **Eight Hundred Ninety Pesos and 83/100 (PhP 246,356,890.83)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
  - (a) General and Special Conditions of the Contract;
  - (b) Notice of Award of the Contract and their conforme thereto:
  - (c) Scope of Works;
  - (d) Drawings/Plans;
  - (e) Bill of Quantities;
  - (f) Performance Security; and
  - Other contract documents that may be required by existing laws and/or the BCDA in the PBDs. The Contractor agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration of the full and satisfactory performance of the services rendered by the Contractor, BCDA shall pay the Contractor the Total Contract Price of Two Hundred Forty Six Million, Three Hundred Fifty Six Thousand, Eight Hundred Ninety Pesos and 83/100 (PhP 246,356,890.83) inclusive of applicable taxes and fees via progress billing.
  - In consideration of the payments to be made by the BCDA to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the ECDA to execute and complete the Construction of Access Road, Drainage and Earthworks at Morong Discovery Park and remedy any defects therein in conformity with the provisions of this Contractor in all respects.
- 5. The BCDA hereby covenants to pay the Contractor in consideration of the execution and completion of actual site accomplishment via progress billing, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times
