<p>1. Clarification in the Terms of Reference section III. Qualification of Bidder:</p> <p><i>The Bidder must have at least five (5) years of existence as a reliable provider of Physical Therapy and Rehabilitation Equipment.</i></p> <p>Can the 5 years be reduced to (2) years?</p>	<p>YES. The provision is revised, to wit:</p> <p><i>The Bidder must have at least two (2) years of existence as a reliable provider of Physical Therapy and Rehabilitation Equipment.</i></p>
<p>2. Clarification in the Bid Data Sheet Section 5.3</p> <p><i>The Bidder must have completed a single contract that is similar to the project equivalent to at least fifty percent (50%) of the ABC; or at least two (2) similar completed contracts with the aggregate amount equivalent to at least fifty percent (50%) of the ABC and the largest of these similar contracts must be equivalent to at least half of the percentage (25%) of the ABC.</i></p> <p><i>For this purpose, contracts similar to the Project shall be Supply and Delivery of Physical Therapy and Rehabilitation Equipment.</i></p> <p>In SLCC, is it possible to aggregate two similar projects?</p> <p>Can we propose 25% of the ABC instead of 50% and to consider the supply and delivery of medical equipment as a similar project?</p>	<p>1. <b>YES.</b> under ITB Clause 5.3 of Bid Data Sheet:</p> <p><i>The Bidder must have completed a single contract that is similar to the project, equivalent to at least fifty percent (50%) of the ABC; or at least two (2) similar completed contracts with the aggregate amount equivalent to at least fifty percent (50%) of the ABC and the largest of these similar contracts must be equivalent to at least half of the percentage (25%) of the ABC.</i></p> <p>2. The bidder can submit two completed contracts with the aggregate amount equivalent to at least fifty percent (50%) of the ABC, as follows:</p> <ol style="list-style-type: none"> <li>Supply and Delivery of Physical Therapy and Rehabilitation Equipment, equivalent to at least 25% of the ABC.</li> <li>Supply and Delivery of Medical Equipment, equivalent to at least 25% of the ABC.</li> </ol>
<p>3. Clarification in the Terms of Reference section III. Qualification of Bidder:</p>	<p><b>YES.</b> The delivery schedule can extend from 120 to 150 calendar days.</p>

<p><i>The procured items shall be delivered within One Hundred Twenty (120) Calendar Days upon the date of receipt of Purchase Order/Notice to Proceed.</i></p> <p>Can we propose for the Delivery be extended to 120-150 days from the issuance of Notice to Proceed since some of these items are made to order internationally and port congestion at Bureau of Customs due to Christmas rush.</p>	
<p>4. When is the schedule for the Site Inspection?</p> <p>Lastly, we would like to inform your good office that we cannot do a site inspection / visit on Monday, December 5, 2022 at Clark since we have Post-Qualification visit / inspection by the Department of Health on the said day.</p>	<p>Site Inspection will be on 07 December 2022 (Wednesday) at 9:00 AM. Site inspection is optional only.</p>
<p>5. Clarification on the venue, date, and time of the Submission of Bids of the prospective bidders</p>	<p>The prospective bidders may submit their bids on the following schedules and venue:</p> <ol style="list-style-type: none"> <li>1) On or before 5:00 PM on 13 December 2022 (Tue) at BCDA Central Receiving and Releasing Area, BCDA Office, Bonifacio Technology Center, Bonifacio Global City, Taguig City; <b>OR</b></li> <li>2) On or before 3:00 PM on 14 December 2022 (Wed) at BCDA Central Receiving and Releasing Area, BCDA Office, 9th Floor, One West Aeropark Bldg., Clark Global City</li> </ol>

The Opening of Bids will be conducted face-to-face at the BCDA 9F One West Aeropark Building Industrial Estate - 5, Clark Global City Clark Freeport Zone, Mabalacat 2023 Pampanga But the bidders may choose to attend the Opening of Bids in person or online, via zoom.

For those who are attending in person, the following guidelines must be followed:

- A maximum of two (2) persons per participating bidder are allowed to attend the Opening of Bids and shall be required to follow the BCDA Health Protocol for Visitors;
- The representative is required to present his/her vaccination card before he/she can be allowed inside the BCDA office;
- Compliance to social distancing, wearing of face masks, and body temperature screening inside BCDA office must be observed; and
- Observers/representatives who show signs of COVID-19 related symptoms such as cough, flu, fever, high body temperature, and sneezing are advised not to proceed to the BCDA Office since they will not be allowed to enter the BCDA premises.
