**RESOLUTION NO. 2023-002
(FAILURE OF BIDDING)**

The **BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA)**, through the 2022 General Appropriations Act, approved the procurement of the **Provision of Road Signages, Wayfinders, Parking Markings and Fabrication of Steel Barriers within the National Government Administrative Center (NGAC) New Clark City, Capas Tarlac** with an Approved Budget for the Contract (ABC) in the amount of **Pesos: Five Million Four Hundred Forty Three Thousand Three Hundred Four and 80/100 (P5,443,304.80)**, inclusive of VAT and all applicable taxes and fees;

WHEREAS, the BAC-I through its Secretariat, advertised/posted the Invitation to Bid including the bidding documents on 02 December 2022 in the following:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, in response to the said advertisements, four (4) prospective bidders attended the Pre-Bid Conference namely: 1) MIF Enterprises, 2) Geotop Construction Supplies, 3) NSB and 4) Mr. Cornelio A. Guisdan held on 22 December 2022 at 11:00 AM;

WHEREAS, the deadline of Submission and Receipt of Bids was scheduled on 13 January 2023, 9:00am, however no bid was received. Thus, the BAC-I convened and declared a failure of bidding for the **Provision of Road Signages, Wayfinders, Parking Markings and Fabrication of Steel Barriers within the National Government Administrative Center (NGAC) New Clark City, Capas Tarlac**, pursuant to Section 35.1 of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (R.A.) No. 9184, to wit:

*"35. 1. The BAC shall declare the bidding a failure when:
a) No bids received;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee for Infrastructure Projects, hereby **RESOLVE** as it is hereby **RESOLVED** the following:

1. To declare a Failure of Bidding for the **Provision of Road Signages, Wayfinders, Parking Markings and Fabrication of Steel Barriers within the National Government Administrative Center (NGAC) New Clark City, Capas Tarlac** in accordance with Section 35.1 of the 2016 Revised Implementing Rules and Regulations (RIRR) of R.A. No. 9184;
2. To direct the end-user, Property and Procurement Management Department (PPMD) to conduct a mandatory review and evaluation of the terms, conditions, and specifications of the Bidding Documents, including the cost estimates, and other requirements relative to this procurement, pursuant to Section 35.2 of the 2016 RIRR of R.A. No. 9184; and
3. To proceed with the rebidding of the Project based on the results of the aforementioned mandatory review pursuant to Section 35.3 of the Revised IRR of RA 9184.
