RESOLUTION NO. BG-DRTK-2022-01 (FAILURE OF BIDDING)

WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA), through the CY 2022 Corporate Operating Budget has bid out the Procurement of Survey Grade Drone with Real Time Kinematic (RTK) and Light Detection and Ranging (LIDAR) with an Approved Budget for the Contract (ABC) of One Million Seven Hundred Fifty Thousand Pesos and 00/100 (Php1,750,000.00), inclusive of VAT and all applicable taxes and fees;

WHEREAS, the Bids and Awards Committee for Goods (BAC-G) advertised/posted the Invitation to Bid including the bidding documents on 24 November 2022 in the following:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, BAC-G has conducted a Pre-bid Conference on 02 December 2022 at 9:00 AM which was attended by the following prospective bidders:

- a. Xitrix Computer Corporation; and
- b. One Commerce (Int'l) Corporation

WHEREAS, during the Opening of Bids on 14 December at 1:30 PM, no bid was received, thus, the BAC-G declared a failure of bidding for the Procurement of Survey Grade Drone with Real Time Kinematic (RTK) and Light Detection and Ranging (LIDAR), pursuant to Section 35.1 of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184, to wit:

"35. 1. The BAC shall declare the bidding a failure when:

 a) No bids received;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee for Goods, hereby **RESOLVE** as it is hereby **RESOLVED** to recommend the following:

- To declare a Failure of Bidding in accordance with Section 35.1 of the 2016 Revised Implementing Rules and Regulations (RIRR) of R.A. No. 9184 for the Procurement of Survey Grade Drone with Real Time Kinematic (RTK) and Light Detection and Ranging (LIDAR); and
- 2. To direct the end-user, Land and Assets Development Department (LADD) to conduct a mandatory review and evaluation of the terms, conditions, and specifications of the Bidding Documents, including the cost estimates, and other requirements relative to this procurement, pursuant to Section 35.2 of the 2016 RIRR of RA 9184.
