**RESOLUTION NO. BG-RPTRE-2022-01
(FAILURE OF BIDDING)**

WHEREAS, the **BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA)**, through the General Appropriations Act FY 2021 (validity extended pursuant to Republic Act No. 11640) has bid out the **Supply, Delivery, and Installation of Physical Therapy and Rehabilitation Equipment for the National Academy of Sports (NAS) - Phase 1 at New Clark City** with an Approved Budget for the Contract (ABC) of **Six Million Six Hundred Thirty-Nine Thousand Pesos and 00/100 (PhP6,639,000.00)**, inclusive of VAT and all applicable taxes and fees;

WHEREAS, the Bids and Awards Committee for Goods (BAC-G) advertised/posted the Invitation to Bid including the bidding documents on 24 November 2022 in the following:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, BAC-G has conducted a Pre-bid Conference on 02 December 2022 at 9:00 AM which was attended by a lone prospective bidder, **Quicklink Consumer Goods Trading**;

WHEREAS, during the Opening of Bids on 14 December 2022 at 3:30 PM, no bid was received, thus, the BAC-G declared a failure of bidding for the **Supply, Delivery, and Installation of Physical Therapy and Rehabilitation Equipment for the National Academy of Sports (NAS) - Phase 1 at New Clark City**, pursuant to Section 35.1 of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184, to wit:

"35. 1. The BAC shall declare the bidding a failure when:

a) No bids received;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee for Goods, hereby **RESOLVE** as it is hereby **RESOLVED** to recommend the following:

1. To declare a Failure of Bidding for the **Procurement of Supply, Delivery, and Installation of Physical Therapy and Rehabilitation Equipment for the National Academy of Sports (NAS) - Phase 1 at New Clark City** in accordance with Section 35.1 of the 2016 Revised Implementing Rules and Regulations (RIRR) of R.A. No. 9184 ; and
2. To direct the end-user, Strategic Projects Management Department (SPMD) to conduct a mandatory review and evaluation of the terms, conditions, and specifications of the Bidding Documents, including the cost estimates, and other requirements relative to this procurement, pursuant to Section 35.2 of the 2016 RIRR of RA 9184.
