The **BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA)**, through the CY 2022 General Appropriations Act, has undertaken the **Procurement of ICT Annual maintenance subscription with On-Site Engineers** with an Approved Budget for the Contract (ABC) of **Twenty One Million, Three Hundred Thousand Pesos and 00/100 (Php 21,300,000.00)**, inclusive of VAT and all other applicable government taxes and fees;

WHEREAS, the Bids and Awards Committee for Goods (**BAC-G**) advertised/posted the Invitation to Bid including the bidding documents on 25 October 2022 in the following:

- DBM Philippine Government Electronic Procurement System (PhilGEPS);
- BCDA Website; and
- In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, BAC-G conducted the Pre-bid Conference on 3 November 2022 at 10:00 AM which was attended by the following prospective bidders:

- Trends & Technologies, Inc.
- Weston Group Inc.
- Macrologic Diversified Technologies Inc.

WHEREAS, in response to said advertisements, Trends & Technologies, Inc. submitted bids before the deadline on 17 November 2022;

WHEREAS, during the Opening of Bids on 17 November 2022 at 10:00 AM, BAC-G received and opened the bidding documents of the sole bidder - Trends & Technologies, Inc., and noted that it passed the eligibility and technical proposal requirements;

WHEREAS, the financial proposal of Trends & Technologies, Inc. was opened and BAC-G noted the following:




NOW, THEREFORE, We, the members of the Bids and Awards Committee for Goods, hereby **RESOLVE**, as it is hereby **RESOLVED**:






