SPORTS (NAS) – PHASE 1 AT NEW CLARK CITY**

RESOLUTION NO. BG-EE-2022-01

The **BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA)**, through the General Appropriations Act FY 2021 (validity extended pursuant to Republic Act No. 11640) has bid out the **Rebidding for the Supply, Delivery and Installation of Electrical Equipment for the National Academy of Sports (NAS) – Phase 1 at New Clark City** with an Approved Budget for the Contract (ABC) of **Thirteen Million Pesos and 00/100 (PhP13,000,000.00)**, inclusive of all applicable taxes and fees;

WHEREAS, the Bids and Awards Committee for Goods (**BAC-G**), through its Secretariat, advertised/posted the Invitation to Bid including the bidding documents on 02 July 2022 in the following:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, BAC-G conducted the Pre-bid Conference on 12 July 2022 which was attended by the following prospective bidders:

- a. Multistyle Specialist, Inc.; and
- b. Philippine Vision Group (PVG) Inc.;
- c. ITC Corp.; and
- d. Superserve Corp.

WHEREAS, BAC-G issued Bid Bulletin No. BAC-G-EQY-2022-01 dated 21 July 2022 clarifying queries raised by the prospective bidders during the pre-bid conference and subsequently, via e-mail.

WHEREAS, in response to said advertisements, only Multistyle Specialist, Inc. submitted its bid before the deadline on 29 July 2022;

WHEREAS, during the Opening of Bids on 29 July 2022 at 11:00 AM, BAC-G received and opened the bid of the lone bidder and noted the following observation:

WHEREAS, Multistyle Specialist, Inc. was declared eligible during the Opening of Bids.

WHEREAS, the financial proposal of Multistyle Specialist, Inc. was opened, as shown in the table below:

WHEREAS, in view of the results of the Detailed Evaluation of Bids on 01 August 2022, the Bids and Awards Committee declared the bid of **Multistyle Specialist, Inc.** as eligible;

WHEREAS, the BAC-G recommended that Multistyle Specialist, Inc. undergo a post qualification on 9-19 August 2022, pursuant to Section 34 of Rule X-Post-Qualification of the Revised Implementing Rules and Regulations (RIRR) of the Republic Act No. 9184;

WHEREAS, BAC-G deliberated on the results of the post-qualification and found that Multistyle Specialist, Inc. is eligible, legally, technically, and financially capable to undertake the project;

NOW, THEREFORE, We, the members of the Bids and Awards Committee for Goods, hereby **RESOLVE**, as it is hereby **RESOLVED**:

1. To declare **Multistyle Specialist, Inc.** as the Single Calculated and Responsive Bidder (SCRB) for the **Rebidding for the Supply, Delivery and Installation of Electrical Equipment for the National Academy of Sports (NAS) – Phase 1 at New Clark City**;
2. To award the contract for the **Rebidding for the Supply, Delivery and Installation of Electrical Equipment for the National Academy of Sports (NAS) – Phase 1 at New Clark City** to **Multistyle Specialist, Inc.** in the amount of **Twelve Million Five Hundred Thousand Nine Hundred Twenty One and 14/100 (Php12,500,921.14)**, inclusive of VAT and all applicable taxes and fees; and
3. To direct the Special Projects Management Department (SPMD), being the end-user unit, to submit to the BAC-G the duly conformed Notice of Award, Notice to Proceed, and the duly executed agreement/contract during the prescribed period.
