## REBIDDING FOR THE SUPPLY, DELIVERY AND INSTALLATION OF NETWORK INFRASTRUCTURE FOR THE NATIONAL ACADEMY OF SPORTS (NAS) – PHASE 1 AT NEW CLARK CITY

## **RESOLUTION NO. BG-NI-2022-01**

The BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA), through the General Appropriations Act FY 2021 (validity extended pursuant to Republic Act No. 11640) has bid out the Rebidding for the Supply, Delivery and Installation of Network Infrastructure for the National Academy of Sports (NAS) — Phase 1 at New Clark City with an Approved Budget for the Contract (ABC) of Twenty Six Million Pesos and 00/100 (PhP26,000,000.00), inclusive of all applicable taxes and fees;

**WHEREAS**, the Bids and Awards Committee for Goods (**BAC-G**), through its Secretariat, advertised/posted the Invitation to Bid including the bidding documents on 02 July 2022 in the following:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

**WHEREAS**, BAC-G conducted the Pre-bid Conference on 12 July 2022 which was attended by the following prospective bidders:

- a. Microgenesis Software, Inc.;
- b. Itraverse Solutions Inc.;
- c. Advance Solutions Inc.;
- d. Multistyle Specialist Inc.,
- e. One Commerce Inc.; and
- f. Pronet

**WHEREAS**, BAC-G issued Bid Bulletin No. BAC-G-ICTE-2022-01 dated 21 July 2022 clarifying queries raised by the prospective bidders during the pre-bid conference and subsequently, via e-mail.

**WHEREAS**, in response to said advertisements, only Microgenesis Software, Inc. submitted bids before the deadline on 29 July 2022;

**WHEREAS**, during the Opening of Bids on 29 July 2022 at 11:00 AM, BAC-G received and opened the bid of the lone bidder and noted the following observation:

WHEREAS, Microgenesis Software, Inc. was declared eligible during the Opening of Bids.

**WHEREAS,** the financial proposal of Microgenesis Software, Inc. was opened, as shown in the table below:

**WHEREAS**, in view of the results of the Detailed Evaluation of Bids on 01 August 2022, the BAC-G has declared the bid of **Microgenesis Software**, **Inc.** as eligible;

The copy of the Detailed Evaluation Report is hereto attached as **Annex B**;

**WHEREAS,** the BAC-G recommended that Microgenesis Software, Inc. undergo a post qualification on 9-19 August 2022, pursuant to Section 34 of Rule X – Post-Qualification of the 2016 Revised Implementing Rules and Regulations (RIRR) of the Republic Act No. 9184;

**WHEREAS,** BAC-G deliberated on the results of the post-qualification and found that Microgenesis Software, Inc. is eligible, legally, technically, and financially capable to undertake the project;

The Post-Qualification Report is hereby attached as **Annex** "C".

**NOW, THEREFORE**, We, the members of the Bids and Awards Committee for Goods, hereby **RESOLVE**, as it is hereby **RESOLVED**:

- To declare Microgenesis Software, Inc. as the Single Calculated and Responsive Bidder (SCRB) for the Rebidding for the Supply, Delivery and Installation of Network Infrastructure for the National Academy of Sports (NAS) – Phase 1 at New Clark City;
- To award the contract for the Rebidding for the Supply, Delivery and Installation of Network Infrastructure for the National Academy of Sports (NAS) Phase 1 at New Clark City to Microgenesis Software, Inc. in the amount of Twenty Four Million Three Hundred Eighty Nine Thousand Four Hundred Thirteen Pesos and 00/100 (Php24,389,413.00), inclusive of VAT and all applicable taxes and fees; and







3. To direct the Special Projects Management Department (SPMD), being the end-user unit, to submit to the BAC-G the duly conformed Notice of Award, Notice to Proceed, and the duly executed agreement/contract during the prescribed period.
