RESOLUTION NO. 2023-006

**Consulting Services for the Construction Management and Supervision (CMS) for the
Construction of Roads, Utilities and Preparatory Works at Morong Discovery Park
(Declaration of Single Rated Bid)**

WHEREAS, the Bases Conversion and Development Authority (BCDA) is mandated under Republic Act No. 7227, as amended by Republic Act No. 7917, to accelerate the sound and balanced conversion into alternative productive uses of the Clark and Subic military reservations and their extensions, to raise funds by the sale of portions of Metro Manila Military Camps and to apply said funds for the development and conversion into alternative productive uses of these properties;

WHEREAS, on **21 January 2023**, the BCDA, through its Bids and Awards Committee for Consulting Services (BAC-C), posted a Request for Expression of Interest (REI) including the bidding documents in PhilGEPS, the BCDA Website, and in a conspicuous place within the premises of BCDA for the **Consulting Services for the Construction Management and Supervision (CMS) for the Construction of Roads, Utilities and Preparatory Works at Morong Discovery Park** under **Section 10 - Competitive Bidding of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184**, with an Approved Budget for the Contract (ABC) in the amount of **Pesos: Forty Million Four Hundred Thirty-Two Thousand and 00/100 (PhP 40,432,000.00)**, inclusive of all applicable taxes and fees;

WHEREAS, in response to the said advertisement of REI and bidding documents, six prospective bidders submitted their Eligibility Documents for the **Consulting Services for the Construction Management and Supervision (CMS) for the Construction of Roads, Utilities and Preparatory Works at Morong Discovery Park** prior to the set deadline for submission on 21 February 2023 at 12:00 p.m., to wit:

- 1) E&R Builders and Management Services, Inc.
- 2) DJMV Management Consultancy & DJM Engineering Consultancy Company Joint Venture,
- 3) KE Asia Incorporated & DCCD Engineering Corporation Joint Venture,
- 4) Urban Integrated Consultant, Inc.,
- 5) Design Science Inc. & Philipps Technical Consultants Corporation Joint Venture, and
- 6) Asyana Construction Consultancy and Trading.

WHEREAS, Section 30.1 of the 2016 Revised IRR of RA 9184 provides:

“xxx... the BAC shall check the submitted documents of each bidder against a checklist of required documents to ascertain if they are all present, using a non-discretionary “pass/fail” criterion, as stated in the Instructions to Bidders. If a bidder submits the required document, it shall be rated “passed” for that particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as “failed.” xxx”

WHEREAS, the submitted Eligibility Documents of the said prospective bidders were opened by determining the presence or absence of the required documents using non-discretionary “pass/fail” criterion on 21 February 2023 at 1:00 p.m.;

WHEREAS, the submitted Eligibility Documents of the said prospective bidders were subjected to detailed evaluation and shortlisting on 22-28 February 2023 in accordance with Section 24 of the 2016 RIRR of R.A. 9184, and using the criteria and rating system for shortlisting as provided under item number 9.2 of Eligibility Data Sheet (EDS) for the consulting services;

WHEREAS, the Technical Working Group (TWG) presented the results of the evaluation of the Eligibility Documents and shortlisting, and the BAC-C deliberated on the results on 03 March, 06 March 2023 and 12 April 2023;

WHEREAS, the results show that five (5) out of six (6) prospective bidders were rated “FAILED” due to the non-compliance with the requirements provided under the Eligibility Documents and Terms of Reference (TOR) for the consulting services, and 2016 RIRR of R.A. 9184;

WHEREAS, the results of the Eligibility Check and Shortlisting likewise show that **E&R Builders and Management Services, Inc.** was rated “PASSED” and garnered a total score of 86.77%, above the minimum required score of 70%, to wit;

WHEREAS, On 12 April 2023, the BAC-C Resolution No. 2023-002 was approved declaring **E&R Builders and Management Services, Inc.** as ELIGIBLE and SHORTLISTED bidder that can proceed to the next stage of the bidding for the Consulting Services pursuant to Section 24.5.4 of RIRR of R.A. 9184. On the same day, the Notice of Eligibility was sent to **E&R Builders and Management Services, Inc.**, inviting them to participate in the bidding for the Consulting Services;

WHEREAS, **E&R Builders and Management Services, Inc.** submitted its Technical and Financial Proposals prior to the deadline set for the submission of Bids for the Consulting Services on 16 May 2023, 12:00 PM. On the same day at 1:00 PM, the Technical Proposal of the sole bidder was opened and subjected to a preliminary examination by determining the presence or absence of the required documents using a non-discretionary “pass/fail” criterion.

WHEREAS, from 17 to 22 May 2023, the BAC-C TWG conducted a detailed evaluation of the Technical Proposal of the sole bidder. On 23 May 2023, the BAC-C deliberated the Report of TWG on the results of the said detailed evaluation. The results show that the Technical Proposal of the sole bidder was rated “PASSED”. Thereafter, the BAC-C issued the Notice to Open the Financial Proposal of the sole bidder **E&R Builders and Management Services, Inc.**;

WHEREAS, on 24 May 2023, the Financial Proposal of **E&R Builders and Management Services, Inc.** was opened and subjected to a preliminary examination by determining the presence or absence of the required document using a non-discretionary “pass/fail” criterion. Thereafter, the Financial Proposal of **E&R Builders and Management Services, Inc.** was evaluated and deliberated upon by the BAC-C. The table below shows the results of the said evaluation of the Financial Proposal:

WHEREAS, the combined numerical ratings of the Technical and Financial Proposals consistent with the Quality-Cost Based Evaluation (QCBE) procedure, with corresponding weights of 70% for Technical Proposal and 30% for Financial Proposal, **E&R Builders and Management Services, Inc.** garnered a total score of 88.74%, with breakdown as follows:

NOW, THEREFORE, foregoing considered and after careful evaluation and thorough deliberation of the detailed evaluation of the submitted Technical and Financial Proposals of the sole bidder **E&R Builders and Management Services, Inc.** for the **Consulting Services for the Construction Management and Supervision for the Construction of Roads, Utilities and Preparatory Works at Morong Discovery Park**, We, the Members of the BAC-C, hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. Approval to declare **E&R Builders and Management Services, Inc.** as the bidder with the Single Rated Bid (SRB) for the **Consulting Services for the Construction Management and Supervision for the Construction of Roads, Utilities and Preparatory Works at Morong Discovery Park** pursuant to Section 33.2.1.2 of the 2016 RIRR of R.A. 9184; and
2. Proceed with the negotiations and conduct of post-qualification of the said bidder in accordance with Section 33.2.5 and 34 of the 2016 RIRR of R.A. 9184, respectively.
