(FAILURE OF BIDDING)**

WHEREAS, the **BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA)**, through the CY 2023 Corporate Operating Budget has bid out the **Procurement for the Laundry Services for the Athletes Village in New Clark City (NCC) Sports Complex** with an Approved Budget for the Contract (ABC) of **One Million Seven Hundred Fifty Thousand Pesos & 00/100 Only (Php 1,750,000.00)**, inclusive of VAT and all applicable government taxes and fees;

The copy of the approved Bids and Awards Committee for Goods (BAC-G) Annual Procurement Plan for CY 2023 is hereto attached as "Annex A"

WHEREAS, the Bids and Awards Committee for Goods (BAC-G) advertised/posted the Invitation to Bid including the bidding documents on 23 March 2023 in the following:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, BAC-G has conducted a Pre-bid Conference on 30 March 2023 at 1:00 PM which was attended by the following prospective bidders;

- a. Friendship Wash & Dry
- b. Suds Premier Franchising Corp.

WHEREAS, during the Opening of Bids and Preliminary Examination on 25 April 2023 at 1:00 PM, the BAC-G opened the eligibility documents of the lone bidder, **Friendship Wash & Dry** and noted deficiencies in its submission and marked them as failed (ineligible) as indicated in *Annex B*. The bidder failed to submit the mandatory documents with its bid as provided in the Bidding Documents, thus the Bidder was ineligible for the opening of its financial proposal.

The copy of the Notice of Ineligibility is hereto attached as "Annex C".

NOW, THEREFORE, We, the Members of the Bids and Awards Committee for Goods, hereby **RESOLVE**, as it is hereby **RESOLVED**, to recommend the following:

1. To declare a Failure of Bidding in accordance with Section 35.1 of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (R.A.) No. 9184 for the **Procurement for the Laundry Services for the Athletes Village in New Clark City (NCC) Sports Complex**; and

No. 9184.
