This Bid Bulletin clarifies written queries received from prospective bidders from June 7 up to 11AM of June 19, 2018, and other matters relative to the Bidding for the Construction of Airport-NCC Access Road (Phase 1).

The contractor shall be paid 15% advance payment upon written request and upon submission to and acceptance by BCDA of an irrevocable standby letter of credit of equivalent value from a commercial bank, a bank guarantee or a surety bond callable upon demand, issued by a surety or insurance company duly license by Insurance Commission.  2. The contractor shall be paid upon completion of each of the following individual phases based on actual quantities certified by BCDA Project Manager:  a. Completion of Sacobia Bridge substructure. |

9. On Item 31.4(f) of Bid Data Sheet, whether the prospective bidders are required to submit the following additional contract documents during the Opening of Bids: These documents are to be submitted after the receipt of the Notice of Award of the Winning Bidder.

- Construction Schedule and S-Curve;
- Manpower schedule;
- Construction methods;
- Equipment Utilization Schedule; and
- Safety and Health Program approved by DOLE.

10. A bidder's Special PCAB License is valid until 30 June 2018, while the Opening of Bids is on 29 June 2018. Is the Special PCAB License acceptable, or do they need to renew the Special PCAB License is Yes, the Special PCAB License would be valid. The bidder will have to renew the Special PCAB License in case their bid is the Lowest Calculated Bid (LCB) and shall undergo post qualification.
