**RESOLUTION OF AWARD  
(RESO NO. BG2018-022)**

**WHEREAS**, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA) has put on bid the Procurement of One (1) Set of Panoramic X-Ray Machine with an Approved Budget for the Contract (ABC) of *Two Million Five Hundred Thousand Pesos & 00/100 (PhP2,500,000.00)*, inclusive of all applicable taxes and fees.

**WHEREAS**, the BAC for Goods, through its Secretariat, advertised the Invitation to Bid on 20 July 2018 in the following:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA

**WHEREAS**, in response to said advertisements, three (3) companies, **Oris Oral Implant Solutions Inc. (Oris)**, Bio-Dent Medical Equipment Trading, and New Citizen's Dental Supply and General Merchandise submitted their bids.

**WHEREAS**, on 09 August 2018, on the scheduled Opening of Bids, the BAC for Goods received three (3) proposals from each of the above-mentioned bidders. During this event, all having submitted the required eligibility documents, the 3 participating bidders were found eligible, thus, their financial proposals were opened.

**WHEREAS**, after preliminary evaluation of the submitted bids by the BAC for Goods, Oris passed and was declared the Lowest Calculated Bid in the amount of *One Million Eight Hundred Ninety Thousand Pesos & 00/100 (PhP1,890,000.00)*, inclusive of all applicable taxes and fees. *The Abstract of Bids is hereby attached as "Annex "A"*.

**WHEREAS**, in view of the foregoing and consistent with Section 34 of Rule X – Post-Qualification of the Revised Implementing Rules and Regulations of Republic Act No. 9184, the Technical Working Group (TWG) of the BAC for Goods conducted Post-Qualification on 23-24 August 2018 to determine whether Oris is compliant with, and is responsive to the requirements and conditions specified in the Bidding Documents.

**WHEREAS**, upon post-qualification conducted by the TWG and after careful examination, validation and verification of all the eligibility, technical and financial documents submitted by Oris, its bid has been found Complying and Responsive. *The Post-Qualification Report is hereby attached as Annex "B"*.

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee for Goods, hereby **RESOLVE** as it is hereby **RESOLVED** to recommend the following:
