## RESOLUTION NO. BG-2018-002

WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA) has put on bid the PROCUREMENT OF FIT-OUT AND FURNISHING FOR THE EXTENSION OFFICE IN CLARK, PAMPANGA with an Approved Budget for the Contract (ABC) in the amount of Pesos: FORTY-SIX MILLION NINE HUNDRED THIRTY FOUR THOUSAND EIGHT HUNDRED SEVENTY-NINE (P46,934,879.00), inclusive of all applicable taxes and fees, with breakdown as follows:

WHEREAS, in accordance with Section 32.2.1 of the Revised Implementing Rules and Regulations (IRR) of RA 9184, the Bids and Awards Committee for Goods (BACG), through the Technical Working group (TWG), conducted a Detailed Bid Evaluation of the financial bid and thereafter finds F.A. Asprer Construction's bid in the amount of P19,065,000.00 as the Single Calculated Bid for Lot A:

WHEREAS, in accordance with Section 34.1 of the Revised Implementing Rules and Regulations (IRR) of RA 9184, the BAC G through the Technical Working Group (TWG) conducted post-qualification on April 12, 2018 of the eligible bidder, F.A. Asprer Construction, to determine whether its bid complies with and is responsive to the requirements and conditions specified in the Bidding Documents;

**WHEREAS**, after careful examination, validation and verification of all the eligibility, legal, technical and financial documents submitted to the BAC-G by F.A. Asprer, the documents were found to be complying and responsive as shown in the TWG Post-Qualification Report (hereto attached as **Annex C**).

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee for Goods, hereby **RESOLVE**, as it is hereby **RESOLVED**, to recommend the following:

- 1. To declare **F.A. ASPRER CONSTRUCTION** as the bidder with the Single Calculated and Responsive Bid (SCRB) for **Lot A** for the Supply and Installation of Fit-out Requirements (including civil, electrical, audio-visual cabling components and structured cabling) with financial bid of **P19,065,000.00**;
- 2. To award the contract to **F.A. ASPRER CONSTRUCTION** for Lot A in the amount of **PhP19,065,000.00** inclusive of all applicable taxes and fees;
- 3. To issue corresponding Notice of Award (NOA) to F.A. ASPRER CONSTRUCTION;
