BIDDING FOR THE PROCUREMENT OF CATERING SERVICES FOR BCDA BOARD MEETINGS, COMMITTEE MEETINGS AND BOARD-RELATED ACTIVITIES FOR 2019

## RESOLUTION OF AWARD (RESO NO. BG-2019-010)

WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA) has put on bid the BIDDING OF CATERING SERVICES FOR BCDA BOARD MEETINGS, COMMITTEE MEETINGS AND BOARD-RELATED ACTIVITIES FOR 2019 with an Approved Budget for the Contract (ABC) of One Million Two Hundred Eight Thousand Four Hundred Pesos (PhP 1,208,400.00), inclusive of all applicable taxes and fees.

**WHEREAS**, the BAC for Goods, through its Secretariat, posted the Invitation to Bid on 10 July 2019 in the following:

- a) DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b) BCDA Website; and
- c) In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, in response to said advertisements, two (2) companies, FUNMANIA, INC. (FunMania) and DPWH CENTRAL OFFICE MULTI-PURPOSE COOPERATIVE (DPWH-COMCO) bought the bid documents.

WHEREAS, on 30 July 2019, on the scheduled Opening of Bids, the BAC for Goods received two (2) proposals from FunMania and DPWH-COMCO. During this event, having submitted the required eligibility both bidders were found eligible, thus, their financial proposals were opened.

WHEREAS, FunMania submitted its bid in the amount of One Million Forty-Three Thousand Forty Pesos (PhP 1,043,040.00) and DPWH-COMCO submitted its bid in the amount of Nine Hundred Fifty-Four Thousand Pesos (PhP 954,000.00), inclusive of all applicable taxes and fees. *The Abstract of Bids is hereby attached as Annex "A"*.

**WHEREAS**, the BAC for Good declared the submission of DPWH-COMCO the Lowest Calculated Bid subject to post-qualification.

WHEREAS, on separate dates, 05 and 07 August 2019, the Technical Working Group (TWG) conducted post-qualification evaluation of DPWH-COMCO to determine whether it is compliant with, and is responsive to the requirements and conditions specified in the Bidding Documents.

WHEREAS, upon post-qualification conducted by the TWG and after careful examination, validation, and verification of all the eligibility, technical, and financial documents submitted by DPWH-COMCO, the BAC for Goods declares its bid POST-DISQUALIFY due to the following reasons:

- a. DPWH-COMCO failed to present the following documents Sanitary Permit issued by the City of Manila; Copy of Valid Cooperative Development Authority (CDA) Certificate; and Certificate of Tax Exemption;
- In addition, during the post-qualification, the TWG observed that DPWH-COMCO have no adequate space/storage and have poor facilities and equipment which failed to comply with the requirements of BCDA; and

On the scheduled Food Tasting and Service Quality Verification on 07 August 2019, DPWH-COMCO failed to show professionalism by being late, not well prepared, and served mostly poor quality of food which made BCDA doubt if the bidder could sustain the demands of the project.

The Post-Qualification Report is hereby attached as Annex "B".

WHEREAS, on 19 and 20 August 2019, the TWG conducted post-qualification evaluation of the Second Lowest Calculated Bid from FunMania to determine whether it is compliant with, and is responsive to the requirements and conditions specified in the Bidding Documents.

WHEREAS, upon conduct of post-qualification and careful examination, validation, and verification of all the eligibility, technical, and financial documents submitted by FunMania, its bid has been found Complying and Responsive. The Post-Qualification Report is hereby attached as Annex "C".

NOW, THEREFORE, We, the Members of the Bids and Awards Committee for Goods, hereby **RESOLVE** as it is hereby **RESOLVED** to recommend the following:

- 1. To declare FUNMANIA, INC. as the bidder with the Lowest Calculated and Responsive Bid for the BIDDING OF CATERING SERVICES FOR BCDA BOARD MEETINGS, COMMITTEE MEETINGS AND BOARD-RELATED ACTIVITIES FOR 2019:
- 2. To award the Contract to FUNMANIA, INC. in the amount of One Million Forty-Three Thousand Forty Pesos (PhP 1,043,040.00), inclusive of all applicable taxes and fees;
- 3. To issue the Notice of Award to FUNMANIA, INC. (copy attached); and,
- To direct the Office of the Corporate Board Secretariat, being the end-user unit, to furnish the BAC for Goods copies of duly conformed Notice of Award, Notice to Proceed, and the duly executed agreement/contract.
