## **BAC-C Resolution Declaring Failed Bidding**

## Consulting Services for the Production of the BCDA 2019 Annual Report

WHEREAS, the President and CEO has approved the procurement of the above services with an Approved Budget for the Contract (ABC) in the amount of Pesos: One Million Five Hundred Thousand and 00/100 (Php 1,500,000.00), inclusive of any and all applicable taxes, fees and incidental expenses;

WHEREAS, The procurement of the said services was undertaken through competitive bidding using Quality-Based Evaluation (QBE) procedure;

WHEREAS, On 26 October 2019, the Bids and Awards Committee for Consultancy (BAC-C) advertised the Request for Expression of Interest (REI) for the said consulting services in the BCDA Website, PhilGEPS Website and in a conspicuous place in the premises of BCDA continuously for seven (7) days;

WHEREAS, a Pre-Eligibility Conference was held on 29 October 2019 and that the following prospective bidders attended:

- 1. Studio 5 Designs, Inc.;
- 2. OP Communications:
- 3. Comm & Sense, Inc.;
- 4. Mode Matrix Manila, Inc.; and
- 5. Team Manila.

WHEREAS, in a letter dated 06 November 2019, Mode Matrix informed the BAC-C that it will not be joining the bidding because it may not be able to meet the deliverables stated in the Terms of Reference.

WHEREAS, no bid was received by the BCDA Central Receiving and Releasing Area (CRRA) by 9:30AM 08 November 2019, the deadline for the submission of the Eligibility Documents.

WHEREAS, pursuant to Section 35.1 of the Revised IRR of Republic Act No. 9184, to wit:

"The BAC shall declare the bidding a failure when:
