DECLARATION OF BIDDER WITH THE HIGHEST RATED BID (HRB)

Consulting Services for the Preparation of Detailed Architectural and Engineering Design for the Replication of the Philippine Navy Facilities

WHEREAS, The BCDA Board approved the procurement of the above consulting services with an Approved Budget for the Contract (ABC) in the amount of Pesos: One Hundred Nineteen Million Nine Hundred Eighty Five Thousand Six Hundred (PhP 119,985,600.00), inclusive of all applicable taxes and fees, to be completed within twelve (12) months;

WHEREAS, On 24 May 2019, the Bids and Awards Committee for Consultancy (BAC-C) advertised the Request for Expression of Interest (REI) for the said consulting services in a newspaper of general nationwide circulation, in the BCDA Website, PhilGEPS Website and in a conspicuous place in the premises of BCDA continuously for seven (7) days;

WHEREAS, on 02 July 2019, the BAC-C issued BAC-C Resolution No. BC2019-019 declaring the following bidders as SHORTLISTED and ELIGIBLE to proceed to the next stage of the bidding process:

- a. TCGI Engineers
- b. A.C. Ong Consulting, Inc.
- c. SMEC Philippines, Inc.

WHEREAS, The procurement of the said services was undertaken through competitive bidding using Quality-Cost Based Evaluation (QCBE) procedure wherein the technical and financial proposals were given corresponding weight equivalent to 70% and 30%, respectively;

WHEREAS, TCGI Engineers and A.C. Ong Consulting, Inc. submitted their Technical and Financial Proposals before the deadline set on 05 August 2019;

WHEREAS, on the same day, at 9:00 AM, the bidders' Technical Proposal were opened and found to be compliant with the requirements under the Checklist of Requirements of the Bidding Documents;

WHEREAS, on the same day, at 1:00 PM, the bidders presented their Plans and Methodology through an Oral Presentation as required under the TOR to selected evaluators composed of BCDA and Philippine Navy representatives;

WHEREAS, after abovementioned activities, the TWG conducted the evaluation of technical proposals based on approved detailed evaluation criteria where the required minimum score is 70%. The results are as follows:

WHEREAS, on 13 August 2019, at 10:00AM, the BAC-C proceeded with the opening of the financial proposals of bidders who passed the required minimum score for technical proposal of 70%;

WHEREAS, all financial bids were found to be within the ABC;

WHEREAS, the results of the combined Technical and Financial evaluation and ranking of the bidders are as follows:
