

BAC-C RESOLUTION NO. BC2019-031

DECLARATION OF BIDDER WITH THE HIGHEST RATED AND RESPONSIVE BID (HRRB)

Consulting Services for the Preparation of Detailed Architectural and Engineering Design for the Replication of the Philippine Navy Facilities

WHEREAS, The BCDA Board approved the procurement of the above consulting services with an Approved Budget for the Contract (ABC) in the amount of Pesos: One Hundred Nineteen Million Nine Hundred Eighty Five Thousand Six Hundred (PhP 119,985,600.00), inclusive of all applicable taxes and fees, to be completed within twelve (12) months;

WHEREAS, On 24 May 2019, the Bids and Awards Committee for Consultancy (BAC-C) advertised the Request for Expression of Interest (REI) for the said consulting services in a newspaper of general nationwide circulation, in the BCDA Website, PhilGEPS Website and in a conspicuous place in the premises of BCDA continuously for seven (7) days;

WHEREAS, The procurement of the said services was undertaken through competitive bidding using Quality-Cost Based Evaluation (QCBE) procedure wherein the technical and financial proposals were given corresponding weights equivalent to 70% and 30%, respectively. Only the financial proposals of bidders who met the minimum technical score of 70% were opened;

WHEREAS, The BAC-C issued Resolution No. BC2019-030 dated 06 September 2019, declaring TCGI Engineers as the bidder with the Highest Rated Bid (HRB) for the above consulting service. Likewise, the said resolution recommended the approval to proceed with the negotiation with TCGI Engineers;

WHEREAS, On 11 September 2019, the BACC conducted negotiation with the HRB pursuant to Section 33.2.5 of the Revised Implementing Rules and Regulations (IRR) of RA 9184;

WHEREAS, after the conduct of successful negotiation, the BAC-C instructed the Technical Working Group (TWG) to undertake the post-qualification activities to verify, validate, and ascertain all statements made and documents submitted by TCGI Engineers;

WHEREAS, after the successful negotiation, the TWG conducted the following post qualification activities:

1. Ocular inspections at TCGI Engineers Office building located at 9th floor, Feliza Building, 108 V.A. Rufino Street, Legazpi Village, 1229 Makati City;
2. Validation of the original copies of Class A legal documents, documents in compliance with labor law such as latest payment to SSS, PhilHealth, and Pag-ibig Fund, and supporting documents for completed and on-going projects;
3. A one-on-one brief interview with all the nominated key personnel to validate work experiences stated in their Curriculum Vitae and ensure personal appearance of the team members;
4. Verification of feedback on the performance of services from their previous clients through phone calls;

WHEREAS, On 13 September 2019, A.C. Ong Consulting, Inc. filed a Motion for Reconsideration (MR) on the post-disqualification decision of the BAC-C. Upon deliberation, the BACC denied the MR of A.C. Ong Consulting, Inc. and informed them of its Decision on 20 September 2019;

WHEREAS, A.C. Ong Consulting, Inc. did not file any protest within the prescribed seven (7) day period;

NOW THEREFORE, after deliberation and premises considered, we, the members of the BAC-C hereby **RESOLVE** to recommend the approval of the following:

1. **RECOMMEND TCGI Engineers** as the bidder with the **Highest Rated and Responsive Bid (HRRB)** for the Consulting Services for the Preparation of Detailed Architectural and Engineering Design for the Replication of Philippine Navy Facilities;
2. **RECOMMEND** the award of the contract to **TCGI Engineers** in the amount of Pesos: One Hundred Nineteen Million Five Hundred Six Thousand Two Hundred Eleven and 44/100 (PhP119,506,211.44), inclusive of all applicable taxes and fees to be completed within twelve (12) months;
3. **DIRECT** the end user to submit to the BAC-C an evaluation of the performance of the consultant at the end of the contract; and
4. **DIRECT** the end user to furnish the BAC-C copies of the duly conformed Notice of Award, Notice to Proceed, as well as the executed contract, and all supporting documents pursuant to the procurement.


