DECLARATION OF ELIGIBLE AND SHORTLISTED BIDDERS

Consulting Services for the Preparation of Detailed Architectural and Engineering Design for the Replication of the Philippine Navy Facilities

WHEREAS, The BCDA Board approved the procurement of the above subject with an Approved Budget for the Contract (ABC) in the amount of Pesos: One Hundred Nineteen Million Nine Hundred Eighty Five Thousand Six Hundred (PhP 119,985,600.00), inclusive of all applicable taxes and fees, to be completed within twelve (12) months;

WHEREAS, The procurement of the said services shall be undertaken through competitive bidding using Quality-Cost Based Evaluation (QCBE) procedure wherein the technical and financial proposals shall be given corresponding weight equivalent to 70% and 30%, respectively:

WHEREAS, On 24 May 2019, the Bids and Awards Committee for Consultancy (BAC-C) advertised the Request for Expression of Interest (REI) for the said consulting services in a newspaper of general nationwide circulation, in the BCDA Website, PhilGEPS Website and in a conspicuous place in the premises of BCDA continuously for seven (7) days;

WHEREAS, On 20 June 2019, the following firms responded to the said advertisement and secured Eligibility Documents for the abovementioned services:

- a. TCGI Engineers
- b. A.C. Ong Consulting, Inc
- c. Consortium of AECOM Phils., Inc., ARCHION Architects and ECOSOLUTIONS Engineers and Project Managers and Sustainable Consultants
- d. SMEC Philippines, Inc.,
- e. L.P. Pariñas & Associates (LPPA), and
- f. Joint Venture Between RCHITECTS, Inc. & Meinhardt Phils., Inc.

WHEREAS, The eligibility documents of L.P. Pariñas & Associates and the Joint Venture (JV) between RCHITECTS, Inc. & Meinhardt Phils., Inc., were not accepted due to late submission. The deadline for the submission of Eligibility Documents as revised under Bid Bulletin No. 01 dated 30 May 2019 was on 20 June 2019 at 10:00 AM;

WHEREAS, The submission of L.P. Pariñas & Associates was stamp received by the BCDA Central Receiving and Releasing Area on 20 June 2019 at 10:01 AM;

WHEREAS, The submission of the JV between RCHITECTS, Inc. & Meinhardt Phils., Inc. was stamp received by the BCDA Central Receiving and Releasing Area on 20 June 2019 at 10:06 AM;;

WHEREAS, On the same day, at 10:30 AM, the BAC-C opened the accomplished eligibility documents of the four (4) proponents, however, only three (3) proponents passed the Eligibility Check based on the non-discretionary "pass/fail" criterion;

WHEREAS, The Consortium of AECOM Phils., Inc., ARCHION Architects and ECOSOLUTIONS Engineers and Project Managers and Sustainable Consultants did not pass the eligibility check because one of its members, ECOSOLUTIONS, failed to submit its BIR Tax Clearance and Audited Financial Statements for CY2018 as part of the eligibility requirements in lieu of PhilGEPS Certificate of Registration;

- 3. RECOMMEND to the Head of Procuring Entity (HoPE) the approval of the foregoing findings.
