NEGOTIATED PROCUREMENT THROUGH SMALL VALUE PROCUREMENT

Consulting Services for the BCDA Web-based Quad-Media Monitoring Project

WHEREAS, Bases Conversion and Development Authority (BCDA) is in need of a fast efficient and effective web-based quad-media monitoring system that would enable the BCDA management to keep abreast of press releases, radio airings and digital information related to BCDA;

WHEREAS, Print, online, radio and TV news media monitoring is essential to the day-to-day operations of the BCDA, especially during crisis situations which require the BCDA management's immediate response;

WHEREAS, BCDA intends to procure and engage the consulting services of an expert in web-based quad-media monitoring who will oversee all news, issues and information related to BCDA in print, media, air broadcast and digital information;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, allows the procuring entity to resort to Small Value Procurement where the procurement does not fall under shopping of Section 52 of the Revised IRR and the amount involved does not exceed the thresholds prescribed in Annex "H" (Consolidated Guidelines for the Alternative Methods of Procurement) of the Revised IRR in the amount of One Million Pesos (Php1,000,000.00) for NGAs, GOCCs, GFIs, SUCs and Autonomous Regional Government;

WHEREAS, On 10th September 2019, the BCDA Corporate Communications Office (CCO), as the end-user, endorsed to the Bids and Awards Committee for Consulting Services (BAC-C) the procurement of consulting services for the web-based quad-media monitoring through Section 53.9 of the Revised IRR on Small Value Procurement;

WHEREAS, The approved budget for the abovementioned consulting services is Pesos: Five Hundred Thousand Pesos (Php500,000.00), for the one (1) year contract, inclusive of all applicable taxes and fees due to government;

WHEREAS, Pursuant to Annex H, Section J, Delegation of Authority, of the Revised IRR, "the conduct of Shopping and Negotiated Procurement under Emergency Cases, Small Value Procurement and Lease of Real Property and Venue may be delegated to the End-user unit or any other appropriate bureau, committee, or support unit duly authorized by the BAC through a Resolution approved by the HOPE.";

WHEREAS, After careful evaluation, the BAC-C finds merit on the recommendation of the CCO for the procurement of consulting services for the web-based quad-media monitoring through Small Value Procurement pursuant to Section 53.9 of the IRR of RA 9184 and its request for delegated authority to undertake the procurement;

NOW, THEREFORE, We, the members of the Bids and Awards Committee for Consulting Services, hereby RESOLVE, as it is hereby RESOLVED to:

- 1. RECOMMEND the procurement of the Consulting Services for the Web-based Quad-Media Monitoring through Section 53.9 of the Revised IRR of RA 9184 of Small Value Procurement for a period of one (1) year upon conforme of the Notice to Proceed;
- 2. DELEGATE the procurement of the aforesaid consulting services to the BCDA Corporate Communications Office, as the end-user unit, subject to compliance with the applicable provisions of RA 9184 and the Revised IRR;
- 3. DIRECT the end-user to furnish the BAC-C copies of the duly conformed Notice of Award and Notice to Proceed as well as the executed Contract within 10-days from execution of the document; and,
- 4. DIRECT the end-user to report to the BAC-C, through a memo, the result of the procurement process within a period of 15 days from the determination that the procurement has succeeded or failed.
