RESOLUTION NO. BG-2019-023

WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA) bid out the **PROCUREMENT OF SUPPLY AND DELIVERY OF 5-ROOM PREFABRICATED BARRACKS THROUGH NEGOTIATED PROCUREMENT** with an Approved Budget for the Contract (ABC) in the amount of **One Million Eight Hundred Thousand Pesos (Php1,800,000.00)**, inclusive of all applicable taxes and fees.

WHEREAS, the Bids and Awards Committee for Goods (BAC-G), through its Secretariat, advertised/posted the Request to Submit Sealed Proposals on 03 December 2019 in the following:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS):
- b. BCDA Website; and
- c. Conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, in response to said advertisement/posting, two (2) companies, VANTAZTIC Incorporated and 3MM Trading submitted their financial proposals.

WHEREAS, on 06 December 2019, the BAC-G opened the financial proposals of VANTAZTIC Incorporated and 3MM Trading. Both financial proposals were below the ABC;

WHEREAS, after preliminary evaluation of the submitted proposals, BAC-G declared the financial proposal of VANTAZTIC Incorporated in the amount of One Million Seven Hundred Fifty Pesos (Php1,000,750.00), inclusive of all applicable taxes and fees, to be the Lowest Calculated Bid. The Abstract of Bids is hereby attached as Annex "A".

WHEREAS, the Technical Working Group (TWG) conducted a post-qualification of VANTAZTIC Incorporated on 12-13 December 2019. After careful examination, validation and verification of all the eligibility requirements, technical and financial documents submitted by VANTAZTIC Incorporated, the BAC-G found VANTAZTIC Incorporated to be non-compliant based on the Post-Qualification requirement, pursuant to Section 34.3.b.ii of the Revised Implementing Rules and Regulations (RIRR) of RA 9184, because it failed to present its Platinum PhilGEPS membership Certificate and Tax Clearance. The Post-Qualification Report of VANTAZTIC Incorporated is attached as Annex "B".

WHEREAS, 3MM Trading submitted a financial proposal in the amount of **One Million Seven Hundred Fifty Thousand Pesos (Php1,750,000.00),** inclusive of all applicable taxes and fees. Having submitted the second lowest calculated bid, the TWG conducted a post-qualification of 3MM Trading on 26-27 December 2019. The Post-Qualification Report of 3MM Trading is hereby attached as Annex "C".

WHEREAS, after careful examination, validation and verification of all documents submitted by 3MM Trading, the BAC-G found its eligibility requirements, technical and financial documents as

Development Authority compliant and responsive with the Terms of Reference (TOR) and likewise compliant with the Post-Qualification Requirement pursuant to the RIRR of RA 9184;

- 2. To award the Contract to 3MM Trading in the amount of One Million Seven Hundred Fifty Thousand Pesos (Php1,750,000.00) inclusive of all applicable taxes and fees;
- 3. To issue the Notice of Award to 3MM Trading (copy attached); and,
- 4. To direct PPMD, being the end-user unit, to furnish the BAC-G copies of the duly conformed Notices of Award, Notices to Proceed and the duly executed agreements/contracts.
